### MEMORANDUM OF AGREEMENT

THIS MEMORANDUM OF AGREEMENT (this "Memorandum"), is made as of April 4, 2017, by and between Kelly Walker ("Kelly") and Teresa M. Walker ("Terri").

#### WITNESSETH:

- A. Kelly and Terri are parties to that certain Tenants In Common Agreement dated as of April 4, 2017 (the "Agreement") with respect to the property at the address commonly known as 725 Park Plaine Avenue, Park Ridge, Illinois 60068, more particularly described on Exhibit A attached hereto and made a part hereof (the "Premises");
  - B. Kelly and Terri are the fee owners of the Premises; and
- B. Kelly and Terri desire to record this Memorandum, in lieu of recording the Agreement itself for the purpose of placing the public on notice of inquiry as to the specific provisions, terms, covenants and conditions of the Agreement, the provisions thereof material to this Memorandum being incorporated herein and made a part hereof by reference.

Without limitation, the Agreement contains the following covenants and agreements between Landlord and Tenant, to-wit:

- 1. <u>Definitions</u>. Capitalized terms used herein which are not otherwise defined herein, shall have the respective meaning ascribed to them in the Agreement.
- 2. <u>Purchase Rights</u>. Each of Kelly and Terri has a right of first offer to purchase the Premises during the Term at fair market value, subject to the terms and conditions set forth in the Agreement.
- 3. <u>Transfer Restrictions</u>. The Agreement requires the consent of all owners of the Premises for certain transfers of an ownership interest in the Premises to third parties.

4. <u>Prohibition on Liens and Encumbrances</u>. The Agreement requires the consent of all owners of the Premises in order to grant a lien on or encumber all or any part of the Premises.

#### 5. Miscellaneous.

- (a) Nothing herein contained is intended to or does change, modify or affect any of the terms or provisions of the Agreement or the rights, duties, obligations, easements and covenants running with the land created thereby, all of which remain in full force and effect.
- (b) This Memorandum is binding on and shall inure to the benefit of the parties and their respective heirs, executors, personal representatives, successors and assigns and shall be appurenant to and shall run with the land.
- (c) This Memorandum may be executed in any number of counterparts, each of which shall be deemed an original, but all of which together shall constitute one and the same instrument.
- (d) This Nepperandum is subject to the terms, conditions and restrictions contained in the unrecorded Agreement.
