

ORDER FOR RECEIVER'S FINAL CERTIFICATE

This matter coming on to be heard on Receiver's Petition for the Court's approval of final accounting and for authorization to issue a receiver's certificates, with due notice being given to all parties and the Court being fully advised in the premises;

THE COURT FINDS:

That on December 22, 2016, Globetrotters Engineering Corporation was appointed limited receiver for the purpose of performing various services at the premises.

That Receiver performed various services as detailed in the final accounting for fees and expenses from 2.

December 22, 2016 through and including Arcil 11, 2017.

That Receiver's final accounting states that, in the course of fulfilling its duties, Receiver incurred out of pocket costs totaling \$337.00, and that \$2,669.35 in fees were billed for a combined total of \$3,005.35.

The Court has in rem jurisdiction over the subject property and the Defendants, such as could be located for service of process, received due notice of the receivers appointment, its accounting and its petition for approval of the final accounting.
