#### A. Agreement to Subordinate

Subordinating Lender and Trustee, if applicable, hereby subording the lien of the Existing Security Instrument, and all of its modifications, extensions and renewals, to the lien of the New Security Instrument. This Agreement is effective as to any sum whose repayment is presently secured or which may in the future be secured by the Existing Security Instrument.
