ASSIGNMENT AGREEMENT (Cook County)

BP Pipelines (North America) Inc., a Maine Corporation, having an office at 30 S. Wacker Drive, Chicago, Illinois 60606 (“Grantor”), for and in consideration of the sum of TEN AND NO/DOLLARS (\$10.00) and other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, hereby assigns, transfers and conveys to **BP D-B Pipeline Company LLC**, a Delaware limited liability company, having an office 150 W. Warrenville Road, Naperville, Illinois 60563 (“Grantee”), without any warranties, express or implied, all of Grantor’s rights, title and interests in and to the real property, or leases, easements, rights-of-way, franchises, permits, licenses and other rights to, or interests in, real property, described on Exhibit A, to the extent Grantor is legally able to make such assignment, transfer and conveyance and subject to the terms and conditions of this Assignment and Conveyance (collectively, the “Assigned Rights”); and Grantee does hereby accept such rights, title and interests in their present “AS-IS, WHERE IS, WITH ALL FAULTS” condition, and does hereby assume all of Grantor’s duties and obligations under or relating to such leases, easements, rights-of-way, franchises, permits, licenses and other rights to, or interests in, real property, on the terms and conditions of this Assignment and Conveyance.

The Assigned Rights, and the assignment, transfer and conveyance of the Assigned Rights under this Assignment and Conveyance, are subject to (a) the terms and conditions of the leases, easements, rights-of-way, franchises, permits, licenses and other rights to, or interests in, real property listed on said Exhibit A, and (b) all easements, covenants, conditions, restrictions, reservations and other matters of record affecting, encumbering or relating to the Assigned Rights.

Notwithstanding the date of execution, this Assignment and Conveyance is effective as of July 1, 2017.

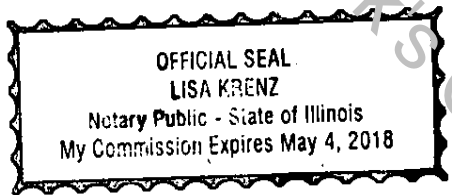
