#### MEMORANDUM OF CONTRACT

THIS MEMORANDUM OF CONTRACT (this "Memorandum"), dated as of the 29th day of June, 2017, is made by and netween FULTON/RACINE PROPERTY, LLC, an Illinois limited liability company ("Seller"), and 1200 WEST FULTON MARKET, LLC, a Delaware limited liability company ("Buyer").

- A.
