



# Last Will and Testament of Suzanne P. Ryan

I, Suzanne P. Ryan, of 1047 South Harvey, Oak Park, Illinois, declare this to be my Last Will and Testament. I hereby revoke all other wills and codicils made by me.

#### ARTICLE ONE

At the time of executing this will, I am married to Richard ("Patrick") Ryan. We have four children My children and their spouses or life partners are:

- 1. Michael Patrick Ryan, also known as Abdul Malik Ryan of Chicago, Illinois, who is marrie, to Moona Malik;
- 2. Martin John Ryan of Chicago, Illinois, who is married to Lisa Sciolaro;
- 3. Daniel Eric Kyan of Homewood, Illinois, who is married to Kristen Dana Ryan, and,
- 4. Rebecca Linusay-Ryan of Evanston, Illinois, whose life partner is Elisabeth Lindsay-Ryan.

For the purposes of this Will, to the extent permissible under Illinois law, a person designated as a "life partner" of one of my descentants or beneficiaries who is not legally married shall have the same rights and interests under this Will as the spouse of a descendant or beneficiary. When used in this Will, the term "spouse" shall include the "life partner" as designated by such descendant or beneficiary who is not legally rearried. In the event that the laws of Illinois are amended to recognize civil unions of persons, which unions are not considered to be the equivalent of marriage by law, then such union shall be considered the equivalent of marriage for purposes of this Will.

#### ARTICLE TWO

The following shall be paid by my Executor: all of my debts that are due and owing at my death, funeral expenses, estate administration expenses and taxes that become parable as a consequence of my death. These payments shall be made from the residue of my estate, without reimbursement to any person.

#### ARTICLE THREE

I give all of my personal effects, household goods and vehicles to my husband, Rinard ("Patrick") Ryan of Oak Park, Illinois, if he survives me. If my husband does not survive me, then I give all of my personal effects, household goods and vehicles to my children, as they shall agree. If my surviving children do not agree within six months of my death, then my personal effects, household goods and vehicles shall be disposed of as my Executor will decide.

#### ARTICLE FOUR

I give all of the rest and residue of my estate to my husband, Richard ("Patrick") Ryan of Oak Park, Illinois, if he survives me. If my husband does not survive me, then I give all of the rest and residue of my estate to my children, their spouses and my descendants, according to the provisions of Article Five through Article Nine of this Will. If any one of the shares created by

Article Five through Article Nine will lapse, that share shall be distributed among my surviving descendants, in proportion to their own shares in this Will.

#### ARTICLE FIVE

If my husband does not survive me, I give one-fourth of the residue of my estate to my son Michael Patrick Ryan, also known as Abdul Malik Ryan. If my son Michael Patrick Ryan, also known as Abdul Malik Ryan does not survive me, then I give one-fourth of the residue of my estate to his wife, Moona Malik. If neither Michael Patrick Ryan, also known as Abdul Malik Ryan nor Moona Malik survive me, then I give one-fourth of the residue of my estate to the children of Michael Patrick Ryan, also known as Abdul Malik Ryan, to be divided among them in equal share. In the event that any of the children of Michael Patrick Ryan, also known as Abdul Malik Ryan, precedes his or her parents and me in death, the share for that grandchild shall pass to that grandchild's spouse, if any. If such predeceased grandchild is survived by descendants, but not a spouse, then that grandchild's share shall pass to the descendants of such predeceased grandchild, per stipper.

If any of my grandchildren named in this Article would be entitled to a share of the residue of my estate, but precede me in dean without leaving either a surviving spouse or descendants, then that predeceased grandchild's shale shall be divided among the other persons designated in this Article, in equal shares.

If none of the persons designated in this Article survives me, then the share shall lapse.

#### ARTICLE SIX

If my husband does not survive me, I give one-fourto of the residue of my estate to my son Martin John Ryan of Chicago, Illinois. If my son Martin John Ryan does not survive me, then I give one-fourth of the residue of my estate to his wife, Lisa Sciolaro. If neither Martin John Ryan nor Lisa Sciolaro survive me, then I give one-fourth of the residue of my estate to the children of Martin John Ryan, in equal shares. In the event that any of the children of Martin John Ryan precedes his or her parents and me in death, the share for that grandchild shall pass to that grandchild's spouse, if any. If such predeceased grandchild is survived by descendants, but not a spouse, then that grandchild's share shall pass to the descendants of such predeceased grandchild, per stirpes.

If any of my grandchildren named in this Article would be entitled to a share of the esidue of my estate, but precede me in death without leaving either a surviving spouse or descendants, then that predeceased grandchild's share shall be divided among the other persons designated in this Article, in equal shares.

If none of the persons designated in this Article survives me, then the share shall lapse.

#### ARTICLE SEVEN

If my husband does not survive me, I give one-fourth of the residue of my estate to my son Daniel Eric Ryan of Homewood, Illinois. If my son Daniel Eric Ryan does not survive me, then I give one-fourth of the residue of my estate to his wife, Kristen Ryan. If neither Daniel Eric Ryan nor Kristen Ryan survive me, then I give one-fourth of the residue of my estate to the children of Daniel Eric Ryan and the children of Kristen Ryan, in equal shares for each child. In the event that any child of Daniel Eric Ryan or child of Kristen Ryan precedes his or her parents and me in

death, the share for that grandchild shall pass to that grandchild's spouse, if any. If such predeceased grandchild is survived by descendants, but not a spouse, then that grandchild's share shall pass to the descendants of such predeceased grandchild, per stirpes.

If any child of Daniel Eric Ryan or child of Kristen Ryan would be entitled to a share of the residue of my estate, but precedes me in death without leaving either a surviving spouse or descendants, then that predeceased grandchild's share shall be divided among the other persons designated in this Article, in equal shares.

If none of the persons designated in this Article survives me, then the share shall lapse.

#### ARTICLE EIGHT

If my husband does not survive me, I give one-fourth of the residue of my estate to my daughter, Rebecca Lindsay-Ryan of Evanston, Illinois. If my daughter, Rebecca Lindsay-Ryan does not survive me, then I give one-fourth of the residue of my estate to her life partner, Elisabeth Lindsay-Ryan. If neither Rebecca Lindsay-Ryan or Elisabeth Lindsay-Ryan survive me, then I give one-fourth of the residue of my estate to the children of Rebecca Lindsay-Ryan, in equal shares. In the event that any of the children of Rebecca Lindsay-Ryan precedes his or her parents and me in death, the share for that grandchild shall pass to that grandchild's spouse, if any. If such predeceased grandchild is survived by descendants, but not a spouse, then that grandchild's share shall pass to the descendants of grandchild, per stirpes.

If any of my grandchildren named in this Article would be entitled to a share of the residue of my estate, but precede me in death without leaving either a surviving spouse or descendants, then that predeceased grandchild's share shall be divided among the other persons designated in this Article, in equal shares.

If none of the persons designated in this Article survives me, then the share shall lapse.

#### **ARTICLE NINE**

If any person designated in this Will receives a share of the residue of my estate, but has not yet reached the age of eighteen years, my Executor shall distribute such share to the Custodian for the minor child, pursuant to the provisions of the Illinois Uniform Gifts to Minor. Act or other relevant state law.

Whenever used in this Will, the words "child" and "children" shall mean any child born tefore or after the date of this Will, regardless of legitimate status, including children both by bloca and by adoption. Whenever used in this Will, the word "descendants" shall mean descendants of whatever degree, regardless of legitimate status, including descendants both by blood and by adoption. For purposes of this Will, a person will be regarded as having been adopted by another only if the adoption is by court proceedings, the finality of which is not being contested by the adopting person. A child in utero will be regarded for purposes of this Will as though such child were then living, but only if such child survives birth.

#### ARTICLE TEN

In disposing of my real estate at 1047 Harvey, Oak Park, Illinois, my Executor shall offer the property for sale as follows: first, to my son Martin John Ryan; second, to my children; third, to my other descendants; fourth, for public sale or auction.

If property is sold by my estate to one or more of my children or descendants, the sale price shall be set by an independent appraisal. The appraiser shall be selected by my Executor and reasonable appraisal costs shall be paid by my estate. The proceeds of such sale shall be distributed as part of the rest and residue of my estate.

If the purchaser is to receive a distribution under this Will, and so agrees, my Executor may reduce the sale price of the real estate and make a corresponding deduction in the purchaser's cash distribution from the residue of my estate. My Executor shall not unreasonably refuse such a request by the purchaser. The value of any price reduction shall be included in the purchaser's share of the residue of my estate.

#### ARTICLE ELEVEN

I appoint my son Daniel Eric Ryan of Homewood, Illinois to be my Executor. If Daniel Eric Ryan fails to act or ceases to act as my Executor, or is unwilling or unable to act, I appoint Martin John Ryan of Chicago, Illinois to be my Executor. If each of the aforementioned persons fail to act or ceases to act as my Executor, or are unwilling or unable to act, my surviving beneficiaries under this Will who are at least 18 years of age shall choose an Executor.

My Executor will serve without compensation or bond.

My Executor will at all times act to the welfare of my beneficiaries, as my Executor deems best. My Executor will not be liable for exploss or depreciation of assets that are retained by my estate.

#### ARTICLE TWILVE

My Executor shall have the full powers and authority granted by law, as well as the following: to sell the property of my estate at public or private sale, without court order, at any time; to mortgage, lease or license the property of my estate; to grant option; to set the terms and prices of sales; to settle and compound any and all claims in favor of my estate or against my estate; to invest and hold property on behalf of my estate's beneficiaries; to enoticy and compensate others to assist in the administration of my estate, and to make, execute and deliver all necessary deeds, contracts, mortgages, bills of sale or other instruments.

#### ARTICLE THIRTEEN

If my husband, Richard ("Patrick") Ryan, dies within 30 days of my death, or if the daws of our deaths are not certain due to a common accident or disaster, the provisions of this Will sha's be effect as if he predeceased me.
