## NOTICE TO INDIVIDUAL SIGNING THE ILLINOIS STATUTYORY SHORT FORM POWER OF ATTORNEY FOR PROPERTY

The purpose of this Power of Attorney is to give your designated "agent" broad powers to handle your financial affairs, which may include the power to pledge, sell, or dispose of any of your real or personal property, ever without your consent or any advance notice to you. This form accornot impose a duty upon your agent to handle your financial affairs, so it is important that you select an agent who will agree to do this for you. 
