The Funds shall be held in an institution whose deposits are insured by a federal agency, instrumentality, or entity (including Lender, if Lender is an institution whose deposits are so insured) or in any Federal Home Loan Bank. Borrower subject to Lender's right to disapprove Borrower's choice, which right shall not be exercised unreasonably. THIS FIXED/ADJUSTABLE RATE RIDER is made this 10th day of July, 2017, and is incorporated into and shall be deemed to amend and supplement the Mortgage, Deed of Trust, or Security Deed (the "Security Instrument") of the same date given by the undersigned ("Borrower") to secure Borrower's Fixed/Adj. stable Rate Note (the "Note") to JPMorgan Chase Bank, N.A. ("Lender") of the same date and covering the property described in the Security Instrument and located at:

THE NOTE PROVIDE'S FOR A CHANGE IN BORROWER'S FIXED INTEREST RATE TO AN ADJUSTABLE INTEREST RATE. THE NOTE LIMITS THE AMOUNT BORROWER'S ADJUSTABLE INTEREST RATE CAN CHANGE AT ANY ONE TIME AND THE MAXIMUM RATE BORROWER MUST PAY.

Additional Covenants. In addition to the covenants and agreements made in the Security Instrument, Borrower and Lender further covenant and agree as follows:

- A. Adjustable Rate and Monthly Payment Changes. The Note provides for an initial fixed interest rate of 2.875%. The Note also provides for a change in the initial fixed rate to an adjustable interest rate, as follows:
- 4. Adjustable Interest Rate and Monthly Payment Changes.
  - (A) Change Dates. The initial fixed interest rate I will pay will change to an adjustable interest rate on the 1st day of August, 2022, and the adjustable interest rate I will pay may change on that day every year thereafter. The date on which my initial fixe interest rate changes to an adjustable interest rate, and each date on which my adjustable interest rate could change, is called a "Change Date".
  - (B) The Index. Beginning with the first Change Date, my adjustable invrest rate will be based on an Index.

The "Index" is One Year Libor. The most recent Index figure available as of the date 45 days before each Change Date is called the "Current Index".

If the Index is no longer available, the Note Holder will choose a new index that is vased upon comparable information. The Note Holder will give me notice of this choice.

(C) Calculation of Changes. Before each Change Date, the Note Holder will calculate ray new interest rate by adding two and one-quarter percentage points (2.250%) to the Current Index. Too Note Holder will then round the result of this addition to the nearest zero and one-eighth percentage point (0.125%). Subject to the limits stated in Section 4(D) below, this rounded amount will be my new interest rate until the next Change Date.

The Note Holder will then determine the amount of the monthly payment that would be sufficient to repay the unpaid principal that I am expected to owe at the Change Date in full on the Maturity

Date at my new interest rate in substantially equal payments. The result of this calculation will be the new amount of my monthly payment.

- (D) Limits on Interest Rate Changes. The interest rate I am required to pay at the first Change Date will not be greater than 4.875% or less than 2.25%. Thereafter, my adjustable interest rate will never be increased or decreased on any single Change Date by more than Two percentage points from the rate of interest I have been paying for the preceding year.
