Thereafter on or about April 7, 2017, Claimant agreed to additional work for the provision of labor and materials for sewer plumbing. On April 22, 2017, the last date on which Claimant provided such labor and material, Claimant had substantially completed the work required of it in a good and workmanlike manner as called for under contract and agreed extra sewer work.

3. That the total amount contracted for was Thirty-Thousand Dollars (\$30,000) and at the request and agreement of the Owner, Claimant provided extra work in the amount of Four Thousand Five Hundred Dollars (\$4,500).
