SLATTERY, Special Assistant Attorney General;

All Defendants having been served as provided by statute and the Court having jurisdiction of this proceeding and of all parties;

Defendants, SUTTON ROAD ANIMAL HOSPITAL P.C., D/B/A SAMUELSON ANIMAL CLINIC P.C.; UNKNOWN OWNERS AND NON-RECORD CLAIM/ANTS having not entered any appearance in this case and having been found by the Court to be in default;

And

The remaining Defendants are RANDAL J, BUTCHNESS; FIRST COMMUNITY BANK; RANDAL J. BUTCHNESS, D.D.S., P.C., D/B/A SUTTON LAKE DENTAL CARE;

Due notice of this hearing having been given;

The Court having heard and considered the evidence and the representations of counsel;

Now, therefore, this Court finds that:

1. The owner and interested parties in Parcel No. 0KA0015, which is legally described in Exhibit A which is attached hereto and incorporated by reference, is:

RANDAL J. BUTCHNESS; FIRST COMMUNITY BANK; RANDAL J. BUTCHNESS, D.D.S., P.C., D/B/A SUTTON LAKE DENTAL CARE;

Said parties are entitled to receive for the taking of fee simple title to Parcel No. 0KA0015 the sum of \$6,800.00 with \$27,200.00 for damages to the Remainder; or \$34,000.00 in total.

- 2. Jus compensation to the owner and interested parties for taking of fee simple title to Parcel No. 0KA 10.5 is \$6,800.00 with \$27,200.00 for damages to the Remainder; or \$34,000.00 in total, and judgment is hereby entered in that amount. The agreed amount includes any claims for interest due from the Claintiff to the Defendants.
- 3. That a motion was heretofore made by the Plaintiff for the immediate vesting to title to Parcel No. 0KA0015 in the Plaintiff, and on the day of June 1, 2016, the court found the amount of preliminary just compensation to be \$34,000.00 in total; that the Plaintiff on June 28, 2016, deposited with the County Treasur or be preliminary just compensation; that on July 7, 2016, the Court ordered that the Plaintiff be vesaed with fee simple title to real property designated as Parcel No. 0KA0015, and did authorize the Plaintiff to take possession thereof.

IT IS ORDERED, ADJUDGED AND DECKCED the payment of \$34,000.00 for the benefit of the owner or interested parties is full and final just compensation including all claims for interest due the Defendants from Plaintiff.

IT IS FURTHER ORDERED, ADJUDGED AND DECREED that the order entered July 7, 2016, vesting the Plaintiff with fee simple title to real property designated as Parcel No. 0KA0015, is confirmed.

IT IS FURTHER ORDERED, ADJUDGED AND DECREED that the cider of default entered against Defendants, SUTTON ROAD ANIMAL HOSPITAL P.C., D/B/A SAMUELSON ANIMAL CLINIC P.C.; UNKNOWN OWNERS AND NON-RECORD CLAIMAN'FS, be and the same hereby is confirmed.
