That on October 5, 2016, the Contractor engaged the Claimant to furnish labor, materials and equipment to furnish and install tile, carpet, and vinyl and related work for the construction and improvements being performed on the Property for the subcontract amount of One Million Four Hundred Fifty Thousand and 00/100 Dollars (\$1,450,000.00). A Subcontract Agreement dated October 22, 2016 was subsequently entered into between the Contractor and Claimant (hereinafter the "Subcontract"). That at the special instance and request of Owner, the Claimant furnished extra and additional labor, materials and equipment on the Property at the cost and value of Four Hundred Sixty-Eight Thousand Five Hundred Sixty-One and 19/100 Dollars (\$468,561.19). On May 31, 2017, the Claimant completed all work required to be performed under the Subcontract, including all extra work, to the value of One Million Nine Hundred Eighteen Thousand Five Hundred Sixty-One and 19/100 Dollars (\$1,918,561.19).
