FIRST AMENDMENT TO MORTGAGE AND SECURITY AGREEMENT

- 1. Amendment of Mortgage. Section 1.1 of the Mortgage is hereby ranended to change the Maturity Date as recited therein from January 1, 2024 to June 30, 2024.
- 2. <u>Ratification; Conflicts</u>. Except as modified hereby, Mortgagor hereby ratifies and reconfirms each and every provision of the Mortgage. In the event of any conflict or inconsistency between the provisions of this Amendment and the Mortgage, this Amendment shall control.
- 3. <u>Severability</u>. In the event that any provision of this Amendment shall be held invalid or unenforceable, such provision shall be severable from, and such invalidity or unenforceability shall not be construed to have any effect on, the remaining provisions of this Amendment.

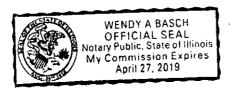
