MODIFICATION OF MORTGAGE

THIS MODIFICATION OF MORTGAGE dated August 1, 2017, is made and executed between **MARK MANFREDI**, whose address is **6846 W. This waiver applies not only to any initial extension or modification, but also to all such subsequent actions.
