- 1. On or before April 19, 2016, Owner owned a parcel of real estate in the County of Cook, State of Il. ir. is described in Exhibit A attached hereto, commonly known as 875 Lake Street, Oak Park, Cook County Illinois 60301 (PIN No. 16-07-129-031-0000) (the "Property").
- 2. On or before April 13, 2016, Owner entered into a general contract with Berglund Construction Company as "Contractor" (the "Contract"), wherein Contractor was to provide labor, materials, and equipment relating to for the restoration of the Unity Temple, 875 Lake Street, Oak Park Illinois 603/31 (the "Project").
- 3. With the knowledge and consent of the Owner, Contractor entered into a Subcontract Agreement dated April 19, 2016 with Paniagua for Project No. 215019 (the "Subcontract"), wherein Paniagua was to provide labor and materials to satisfy Contract Drawings and Specifications PK-1 and PK-2 dated June 10, 2015 and June 1, 2015 respectively, and together with Addendum No. 1 dated June 12, 2015, Addendum No. 2 dated June 15, 2015, and Addendum No. 3 dated July 6, 2015 (the "Work") at the Project. According to the Subcontract, the lump sum amount to be paid to Paniagua for the Work was \$64,191.00 (the "Contract Sum").
- 4. On June 12, 2017, Paniagua performed its last day of Work required by the contract to be done as of that date, including a net reduction of \$388.00 due to changes to the Work, such that the adjusted Contract Sum of \$63,803.00 became due and owing.
- 5. The Owner has left unpaid, due and owing to Paniagua, the sum of \$63,803.00 for which, with interest, Paniagua claims a lien on the Property and improvements and to monies or other considerations due or to become due from Owner under the Contract.
