2. The Department deposited the preliminary just compensation of \$600.00 with the Cook County Treasurer on June 23, 2017.


IT IS THEREFORE ORDERED:


- A. Pursuant to 735 ILCS 30/20-5-15, the Department of Transportation of the State of Illinois is vested with the following property rights:
