#### **ORDER**

This cause is before the Court on Plaintiff Northbrook Bank & Trust Company's Motion for Surmary Judgment against Defendants Robert Baroud, Peter Baroud, Emil Baroud, Anthony Baroud, and Abe Baroud. Plaintiff's Complaint alleges that, pursuant to a note, Defendants failed to make payments to Plaintiff in the amount of \$51,352.00, plus interest. Defendants' Answer to Plaintiff's Complaint only alleges that Defendants "have insufficient knowledge to admit or deny" each of Plaintiff's allegations. In support of its Motion for Summary Judgment, Plaintiff provides the affidavit of Michael J. Schram ("Schram"), the Assistant Vice President of Plaintiff. Schram's affidavit that Defendants are liable for a total amount of \$54,008.02, which consists of a principal amount of \$44,837.59; \$2,046.64 in interest; \$1,081.80 in late charges; and \$6,041.99 in court costs and attorney fees. Defendants have filed no response to conner-affidavit to Plaintiff's Motion for Summary Judgment. Thus, due notice having been given, and this Court being fully advised in the premises;

#### IT IS HEREBY ORDERED:

- (1) Plaintiff's Motion for Summary Judgment against Defendance is granted;
- (2) Judgment in the amount of \$54,008.02 is hereby entered in favor of Plaintiff Northbrook Bank & Trust Company and against Defendants Robert Baroud, Peter Baroud, Emil Baroud, Anthony Baroud, and Abe Baroud, which consists of the following amounts: a principal amount of \$44,837.59; \$2,046.64 in interest; \$1,081.80 in late charges; and \$6,041.99 in court costs and attorney fees;
