This matter coming before the Court for a prove-up of Plaintiffs' damages, the Court having entered an Order of Default against Defendant Ashley's Quality Care, Inc., notice having been given to Defendant Ashley's Quality Care, Inc., and the Court having reviewed the Declarations of Plaintiffs and their Counsel,

IT IS HEREBY ORDERED that:

1. Defendant Ashley's Quality Care, Inc. is liable to Plaintiffs Gustavo Acosta and Maria del Carmen Rau for unpaid earned wages and statutory damages pursuant to the Illinois Wage Payment and Collection Act, 820 ILCS 115/1 *et seq.*
2. Plaintiffs are awarded Judgment against Defendant Ashley's Quality Care, Inc. as follows:
 - a. Plaintiff Gustavo Acosta is awarded Judgment in the amount of \$2,461.97, with \$2,094.00 as owed wages and \$367.97 as statutory interest;

b. Plaintiff Maria del Carmen Rau is awarded Judgment in the amount of \$2,776.31, with \$2,304.75 as owed wages and \$471.56 as statutory interest.

3. Plaintiffs' Counsel is awarded Judgment against Defendant Ashley's Quality Care, Inc. in the amount of \$469.90 for costs and expenses in litigating this matter.

4. Plaintiffs' Counsel is awarded Judgment against Defendant Ashley's Quality Care, Inc. in the total amount of \$3,635.00 for attorneys' fees in litigating this matter as specified below:
