
DECLARATION OF WITHDRAWAL FOR DRUMMOND SQUARE CONDOMINIUM

WHEREAS, Wintrust is the holder of all liens affecting any of the units by virtue of a Construction Mortgage, Security Agreement, Assignment of Rents and Leases and Fixture Filing dated April 26, 2017 and recorded in the office of the Cook County Recorder of Deeds on May 3, 2017 as Document No. 1712341083 and an Assignment of Rents and Leases made and recorded as of the same date as Document No. 1712341084; and
