SPECIAL AMENDMENT TO DECLARATION OF COVENANTS, CONDITIONS, KESTRICTIONS AND EASEMENTS

This Special Amendment to Declaration of Covenants, Conditions, Restrictions and Easements ("Special Amendmen.") is made and entered into as of the <u>15</u> day of June, 2017 by LMC OAK PARK HOLDINGS, LLC. a Delaware limited liability company ("Declarant").

RECITALS

Whereas, the terms used in the Recitals, if not otherwise defined in the Recitals, shall have the respective meanings set forth in the Declaration (as defined below); and

Whereas, Declarant was the fee simple title owner of land located in the Village of Oak Park, Cook County, Illinois and legally described on Extilit A attached hereto (the "Land"); and

Whereas, Declarant entered into that certain Declaration of Covenants, Conditions, Restrictions and Easements on May 1, 2017, which instrument was recorded against the Land on May 4, 2017 as document number 1712445085 (the "Declaration"); and

Whereas, Declarant erected the North Building and the South Building on the Land and upon the recording of the Declaration, divided the North Building and the South Building into six (6) legal parcels as follows: the North Retail Parcel, the North Apartment Parcel, the South Retail Parcel, the Garage Parcel, the South Apartment Parcel and the Future Retail Parcel; and

Whereas, Declarant conveyed fee simple title to the North Retail Parcel (legally described on Exhibit C attached hereto) to CSD Kurtzein, LLC ("CSD Kurtzein") and Declarant continues to own fee simple title to the North Apartment Parcel (legally described on Exhibit B attached hereto), the South Retail Parcel (legally described on Exhibit F attached hereto), the Garage Parcel (legally described on Exhibit D attached hereto), the South Apartment Parcel (legally described on Exhibit E attached hereto) and the Future Retail Parcel (legally described on Exhibit G attached hereto).

Whereas, the Declaration contains certain clerical, scrivener and/or typographical errors; and

Whereas, Article 20 of the Declaration confers upon Declarant the right and power to record a Special Amendment to the Declaration to correct clerical, scrivener and/or typographical errors in the Declaration; and

Whereas, Declarant desires to modify and amend the Declaration to correct those certain clerical, scrivener and/or typographical errors contained in Article 8, Section 25.1, and Exhibits D, E, F and G to the Declaration.

NOW, THEREFORE, in consideration of the foregoing recitals, the mutual covenants and agreements herein contained and other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, it is agreed that the Declaration shall be amended in the following particulars:

- 1. <u>Recital</u>. The recitals set forth above are restated by this reference. The capitalized words and terms set forth in this Special Amendment shall have the same definition as set forth in the Declaration, unless provided to the contrary herein.
- 2. <u>Legal Description of the Garage Parcel</u>. The legal description contained in Exhibit D to the Declaration is hereby ar rended to correct a clerical error discovered by the surveyor after the Declaration was recorded by deleting same in its entirety and substituting in its place the legal description shown below and on Exhibit D attached hereto.
- 3. <u>Legal Description of the South Apar ment Parcel</u>. The legal description contained in Exhibit E to the Declaration is hereby a nended to correct a clerical error discovered by the surveyor after the Declaration was recorded by deleting same in its entirety and substituting in its place the legal description shown below and on Exhibit E attached hereto.
- 4. <u>Legal Description of the South Retail Parcel</u>. The legal description contained in Exhibit F to the Declaration is hereby amended to correct a clerical error discovered by the surveyor after the Declaration was recorded by deleting same in its entirety and substituting in its place the legal description shown below and on Exhibit F attached hereto.
- 5. <u>Legal Description of the Future Retail Parcel</u>. The legal description comained in Exhibit G to the Declaration is hereby amended to correct a clerical error discovered by the surveyor after the Declaration was recorded by deleting same in its entirety and substituting in its place the legal description shown below and on Exhibit G attached hereto.
- 6. <u>Retail Parcels</u>. Section 2.50 of the Declaration defines the "Retail Parcels" as the North Retail Parcel, the South Retail Parcel and/or the Future Retail Parcel and Section 25.1 of the Declaration defines the "Retail Parcels" as the North Retail Parcel and the South Retail Parcel, but not the Future Retail Parcel. The failure of Section 25.1 of the Declaration to include the Future Retail Parcel in the definition of "Retail Parcels" is a clerical error. Therefore, and notwithstanding anything to the contrary contained in the Declaration, any and all references in the Declaration to the "Retail Parcels" means, collectively (or

individually, as the context requires), the North Retail Parcel, the South Retail Parcel and the Future Retail Parcel.

Further, the caption in Section 25.2 of the Declaration is hereby deleted in its entirety and is replaced by the following caption: Other Restrictions Applicable to the North Retail Parcel, the South Retail Parcel, and the Future Retail Parcel, which replacement corrects the clerical error of the failure to include the Future Retail Parcel in said caption.

7. Percentage Shares of Real Estate Taxes. Section 8.2 of the Declaration describes Percentage Shares that do not add up to 100% and the failure of said Section 8.2 to reflect Percentage Shares that add up to 100% is a clerical error. Accordingly, the second sentence of Section 8.2 of the Declaration is hereby deleted in its entirety and is replaced with the following:

"The pe centage share of the total real estate tax bills payable by each Owner shall be as follows: the percentage share of the Owner of the North Apartment Parcel shall be 18.53%; the percentage share of the Owner of the South Apartment Parcel shall be 43.89%; the percentage share of the Owner of the Garage Parcel shall be 31.96%; the percentage share of the Owner of the North Retail Parcel shall be 4.91%; the percentage share of the Owner of the South Retail Parcel shall be 4.7%; and the percentage share of the Owner of the Future Retail Parcel shall be .24% (each a "Percentage Share(s))."

- 8. <u>Exhibits I and J.</u> The documents attached to the Declaration as Exhibits I and J are reversed. The correct "Sign Location" exhibit is attached as Exhibit J but it should be attached as Exhibit I and the correct "Approved way finder and tenant identification signage in the Garage Parcel Improvements" exhibit is attached as Exhibit I but it should be attached as Exhibit J.
- 9. Power Coupled with an Interest. The Declarant's right and power in Article 20 to record this Special Amendment contains a power coupled with an interest. The Declarant has the right and power under said Article 20 to record this Special Amendment on behalf of each Owner as proxy or attorney-in-fact and each deed, mortgage, trust deed, other evidence of obligation, or other instrument affecting any portion of the P. cject, and the acceptance thereof is deemed to be a grant and acknowledgment of, and a consent to the reservation of, the power to Declarant to vote in favor of, make, execute and record this Special Amendment. Therefore, each Owner and mortgagee of a Parcel is subject to the terms of this Special Amendment.
- 10. <u>No Modification; Conflict.</u> Except as amended in this Special Amendment, all of the terms, covenants, conditions, agreements and provisions set forth in the Declaration shall remain unchanged and shall be and they hereby are reaffirmed, ratified, confirmed and approved in their entirety and shall remain in full force and effect. In the event of any conflict or inconsistency between the provisions of this Special Amendment and the provisions of the Declaration, the provisions of this Special Amendment shall in all instances govern and control. Except as herein modified, the Declaration shall remain unchanged, unmodified and in full force and effect.
