ORDER VESTING TITLE

This case coming to be heard on Plaintiff's, the Department of Transportation of the State of Illinois ("IDOT"), Motion for Entry of Order Vesting Title, due notice having been given, and the Court having been fully advised in the premises,

HEREBY FINDS:

1. On June 27, 2017, the Court entered an order pursuant to 735 ILCS 30/20-5-10 setting the preliminary just compensation at \$1,400.00. IDOT seeks to acquire full fee simple title to the real property designated as Parcel 0L70145, legally described in Exhibit A, and a temporary easement for construction purposes for a period not to exceed five years, or until completion of construction operations, whichever occurs first, across and upon the real property designated as Parcel 0L70145TE, legally described in Exhibit B.

2. IDOT deposited the preliminary just compensation of \$1,400.00 with the Cook County Treasurer on August 17, 2017.

 - 1. Full fee simple title to the real property designated as Parcel 0L70145; and
 - a temporary easement for construction purposes for a period not to exceed five years, or until completion of construction operations, whichever occurs first, across and upon the real property designated as Parcel 0170145TE.
