- 3. The Contract was entered into by Mitchello as Owner's agent, and the work was performed with the knowledge and consent of Owner. Alternatively, Owner authorized Mitchello to enter into the Contract. Alternatively, Owner knowingly permitted Mitchello to enter into the Contract for the improvement of the Real Estate.
- 4. Claimant performed additional work in the amount of \$1,30.60 at the request of Mitchello, as Owner's agent or as an entity authorized by Owner or knowingly permitted by Owner so that the final adjusted contract sum was \$10,076.46.
 - 5. Claimant completed the work for which Claimant claims a lien on August 15, 2017.

As of the date hereof, there is due, unpaid, and owing to Claimant, after allowing all credits, the principal sum of \$7,399.71 which principal amount bears interest at the statutory rate of 9 percent per annum. Claimant claims a lien on the Real Estate (including all land and improvements thereon) in the amount of \$7,399.71 plus interest.
 - 7. Claimant revokes any waiver of rights for which Claimant has not received payment.
