FUNERAL HOME BUSINESS AND/OR RELATED SERVICES, AND NECESSARY PARKING AND OUT BUILDINGS IN CONNECTION THEREWITH, WITHOUT PRIOR WRITTEN APPROVAL AND AUTHORIZATION FROM THE BETHANIA ASSOCIATION BOARD OF DIRECTORS, OR ITS SUCCESSORS AND/OR ASSIGNS;

FURTHER, IN THE EVENT THE REAL ESTATE IS EVER PUT TO A USE OTHER THAN A CREMATORY AND/OR A FUNERAL HOME AND/OR RELATED SERVICES, NECESSARY PARKING AND OUT BUILDINGS IN CONNECTION THEREWITH, OR IN THE EVENT OF A BURIAL, SCATTERING, INURING, OR ENTOMBMENT OF HUMAN REMAINS ON THE PREMISES, THIS PROVISION MAY BE ENFORCED BY A COURT OF COMPETENT JURISDICTION, AND THE GRANTEE (AND ITS SUCCESSOR(S) AND ASSIGNS) SHALL BE LIABLE TO BETHANIA ASSOCIATION FOR ALL OF ITS COSTS, INCLUDING REASONABLE ATTORNEY'S FEES AND COSTS, IN ENFORCEMENT HEREOF; PROVIDED, HOWEVER, BETHANIA ASSOCIATION MAY RELEASE THIS RESTRICTION BY INSTRUMENT DULY RECORDED WITH THE COOK COUNTY RECORDER OF DEEDS. THIS RESTRICTIVE COVENANT SHALL BE DEEMED TO BE A COVENANT RUNNING WITH THE LAND, AND SHALL APPEAR IN THE DEED OF CONVEYANCE TO PURCHASER; AND

BETHANIA ASSOCIATION'S PERPETUAL FIRST RIGHT OF REFUSAL IN THE EVENT THE PURCHASER/GRANTEE, OR 11'5 SUCCESSORS OR ASSIGNS, DESIRE(S) TO SELL "THE PREMISES" TO A THIRD PARTY AT ANY TIME HEREAFTER.
