CONSEN' TO ASSIGNMENT AND AGREEMENT REGARDING FUTURE CONSENTS

This Consent to Ass grment and Agreement regarding Future Consents (this "Agreement") is effective as of September 25 2017 and is given by KFC CORPORATION, a Delaware corporation ("Predecessor Assignor") to EDDIES RESTAURANT COMPANY, an Illinois corporation ("Assignor") for the benefit of Assignor and its successors and assigns, including, but not limited to, FQSR, LLC, a Delaware limited liability company ("Assignee") and its successors and assigns.

- 3. Predecessor Assignor hereby consents to all amendments or other modifications of the Lease to-date to which it has given prior concent pursuant to the terms of the Lease or which do not materially affect the rights of Predecessor Assignor.
 - 4. Predecessor Assignor hereby consents to the assignment of the Lease to Assignee.
- 5. Predecessor Assignor hereby consents to all future amendments and modifications of the Lease, so long as such future amendments and modifications do not have the purpose or effect of increasing the liabilities and/or obligations of Predecessor Assignor from those contemplated and contained in the Lease (as such term is defined herein) or materially alter the terms of the Lease.
- 6. This Agreement shall be binding upon and inure to the benefit of the parties hereto and their respective successors in interest and assigns.
