This matter coming to be heard on the Illinois State Toll Highway Authority's (the "ISTHA") Complaint for Condemnation, Amendment to Complaint for Condemnation, and Motion for Summary Judgment to acquire fee simple title to Parcel NW-7A-12-103, legally described in Exhibit A; a temporary easement for construction purposes for a period not to exceed five years from the date of vesting of title or until completion of construction operations, whichever occurs first, across and upon Parcel NW-7A-12-103.T, legally described in Exhibit B; fee simple title to Parcel NW-7A-12-103.EX, legally described in Exhibit C; and to ascertain the just compensation to be paid for this acquisition, the Court, having been fully advised in the premises, HEREBY FINDS:

- 3. Parcel NW-7A-12-103, Parcel NW-7A-12-103.T., and Parcel NW-7A-12-103.EX is located in Cook County, Illinois (the "Subject Property").
- 4. The Court has jurisdiction over the parties and over the Subject Property in this proceeding.
- 5. Cr March 16, 2017, default judgment was granted against defendants Unknown Owners and Non-Record Claimants.
- 6. On September 27, 2017, default judgment was granted against defendant Green,
 Inc.
- 7. Pursuant to the ISTHA's Pirst Motion for Immediate Vesting of Title, the Court entered an order on April 13, 2016 setting the preliminary just compensation at \$3,500.00 for the taking of Parcel NW-7A-12-103 and Parcel NW-7A-12-103.T.
- 8. On April 26, 2016, the ISTHA deposited the preliminary just compensation of \$3,500.00 with the Cook County Treasurer.
- 9. On May 4, 2016, the Court entered an order vesting the .STHA with title to Parcel NW-7A-12-103 and Parcel NW-7A-12-103.T.
- 10. On April 20, 2017, the Court granted the ISTHA's motion for leave to file an Amendment to the Complaint for Condemnation, adding a fee simple taking of Parcel NW-7A-12-103.EX.
- 11. Pursuant to the ISTHA's Second Motion for Immediate Vesting of Title, the Court entered an order on May 10, 2017 setting the preliminary just compensation at \$9,500.00 for the taking of Parcel NW-7A-12-103.EX.
