TERMINATION AND RELEASE OF EASEMANT AGREEMENT

THIS TERMINATION OF EASEMENT AGREEMENT (this "<u>Termination Agreement</u>") is made as of October 25, 2017, by Broadway ADP, LLC, at Illinois limited liability company ("<u>Broadway ADP</u>").

RECITALS

- A. Pursuant to that certain Indenture recorded February 11, 1970 as Document Number 21082862 (the "Easement Agreement") by and between Herbert J. Cobos and Florence Cobbs (collectively, "Grantors"), and Uptown Federal Savings and Loan Association of Chicago, a corporation of the United States of America, its successors and assigns ("Grantee"), Grantors granted certain easement rights to Grantee as more particularly set forth in the Easement Agreement over the real property more particularly described on Exhibit A attached hereto (the "Easement Area")
- B. Subsequent to the entering into of the Easement Agreement, Grantee acquired fee simple title to the Easement Area. Broadway ADP is successor-in-interest to Grantee and the current owner of the Easement Area.
