MEMORANDUM OF FUEL SUPPLY AGREEMENT

NOW COME LAKE SHORE PETROLEUM, LLC an Illinois Limited Liability Company (hereinafter "LSP"), having its principal offices at 10 E 22nd St., Suite# 210, Lombard, IL 60148, (hereinafter "Distributor") and the following purchasing party/parties, hereinafter ("Purchasers"), HAWTHORN PROPERTIES LLC, an Illinois limited liability company, and HARJINDER SINGH aka HARJINDER SANDHU, individually, and by this Memorandum put on notice all having any relationship to the following real properties (the "Locations"), that on November 19, 2015, Distributor and Purchasers entered into a Fuel Supply Agreement (the "Agreement") for the Locations, and each of them, which commenced on November 19, 2015, and runs through at least December 31, 2035, and shall be automatically renewed, unless earlier terminated as provided in the Agreement, and continue in force and effect for additional one year periods through each subsequent anniversary, unless certain notice is given.

The Agreement survives any sale, transfer or assignment to any third party by Purchaser or by any landlord ("Landlord"), lessor, lessee or sub lessee(s) or by any owner of the Location ("Owner of Location") or Mortgagee of the Location and will run with the land upon recording and any such sale, transfer or assignment to a third party must be approved in writing by Distributor

and the third party must honor this fuel supply agreement which cannot be cancelled or modified without the express written approval of Distributor.

UNOFFICIAL COPY

The Distributor has the first right to purchase the real estate at any Location.

All credit card transactions for the Location must be processed through the Distributor using only a credit card processing system provided by Distributor.

All other terms of the Fuel Supply Agreement remain in full force and effect.






