CONSTRUCTION MORTGAGE, SECURITY AGREEMENT, FIXTURE FILING AND ASSIGNMENT OF LEASES AND RENTS

THIS CONSTRUCTION MORTGAGE, SECURITY AGREEMENT, FIXTURE FILING AND ASSIGNMENT OF LEASES AND RENTS (this "Mortgage") is made as of November 17, 2017, by WABASH PARKING LLC, formerly known as Waterton River Plaza, L.L.C., a Delaware limited liability company ("Waterton Parking Borrower") for the benefit of CIBC BANK USA, an Illinois banking corporation, its successors and assigns, as administrative agent for the "Lenders" (as defined below) (the "Administrative Agent").

WITNESSETH:

Pursuant to that certain Construction I oan and Security Agreement of even date herewith by and among Administrative Agent, Waterton Parking Borrower and Wabash Condominium LLC, an Illinois limited liability company ("Wabash Condominium Borrower," and together with Waterton Parking Borrower, jointly and severally, the "Borrower") and those certain financial institutions that are, or may become from time to time, parties thereto (collectively, with CIBC Bank USA, in its individual capacity, the "Lenders"), the provisions of which are incorporated herein by reference to the same extent as if fully set forth herein (said Loan Agreement and any and all extensions and renewals thereof, amendments thereto and substitutions or replacements therefor is referred to herein as the "Loan Agreement"; any terms not defined herein shall have the meanings ascribed to such terms in the Loan Agreement), Lenders are making a loan to Borrower (the "Loan") in an amount not to acceed SIXTY-THREE MILLION SIX HUNDRED NINETY THOUSAND AND 00/100 DOLLARS (\$63,690,000.00). The Loan is evidenced by one or more syndicated Promissory Notes dated as of even date herewith in the original aggregate principal amount of up to \$63,690,000.00 from Borrower to Lenders (the "Notes"). The Loan is due and payable in full on November 17, 2020 (the "Maturity Date"), except as such date may be extended to November 17, 2021 pursuant to the terms of the Loan Agreement or accelerated pursuant to the terms hereof or of any other Loan Document (as hereinafter defined). This Mortgage encumbers certain real estate located in Cook County, Illinois, legally described on Exhibit A attached hereto, and payment of the Notes is secured by this Mortgage, a certain mortgage from Wabash Condominium Borrower dated as of even date herewith, encumbering certain property owned by Wabash Condominium Borrower (the "Wabash Condominium Mortgage," and together with this Mortgage, the "Mortgages") financing statements and other security documents (the Mortgages, the Notes, the Loan Agreement, the Letter of Credit Documents (as defined below), any Interest Rate Protection

Agreements (as defined below), and all other documents evidencing or securing the Loan (as amended, modified, replaced or restated from time to time) are collectively hereinafter referred to as the "Loan Documents"). As used herein, "Letter of Credit Documents" shall mean all documents evidencing or securing any letter of credit issued by Administrative Agent for the benefit of Waterton Parking Borrower (including but not limited to that certain Master Letter of Credit Agreement, if any, dated on or about the date hereof from Waterton Parking Borrower to Administrative Agent), and the term "Interest Rate Protection Agreements" shall mean any agreement providing for payments which are related to fluctuations of interest rates, exchange rates, forward rates, or equity prices, including, but not limited to, dollar-denominated or crosscurrency interest rate exchange agreements, forward currency exchange agreements, interest rate cap or collar protection agreements, forward rate currency or interest rate options, puts and warrants, and any agreement pertaining to equity derivative transactions (e.g., equity or equity index swaps, options, caps, floors, collars and forwards), including without limitation, any ISDA Master Agreement between Waterton Parking Borrower and any Lenders, and any schedules, confirmations and documents and other confirming evidence between the parties confirming transactions thereunder all whether now existing or hereafter arising, and in each case as amended, modified or supplemented from time to time. The Loan bears interest at a variable rate of interest. All initially capitalized terms herein not expressly defined herein shall have the definitions given such terms in the Lo in Agreement.

To secure (i) the payment when and as due and payable of the principal of and interest on the Loan or so much thereof as may be advanced from time to time, and any and all late charges, Additional Costs, and all other indebtedness evidenced by or owing under the Notes and any of the other Loan Documents, together with any extensions, modifications, renewals or refinancings of any of the foregoing, (ii) the payment of all other indebtedness which this Mortgage by its terms secures, and (iii) the performance and observance of the covenants and agreements contained in this Mortgage, the Loan Agreement, the Notes and each of the other Loan Documents, and (iv) all obligations and liabilities of the V/aterton Parking Borrower to Administrative Agent under the Interest Rate Protection Agreements and the Letter of Credit Documents, if any (all of such indebtedness, obligations and liabilities identified in (i), (ii), (iii) and (iv) above being hereinafter referred to as the "Debt"), the Waterton Parking Borrower does hereby GRANT, SELL, CONVEY, MORTGAGE and ASSIGN unto the Administrative Agent, its successors and assigns, and does hereby grant to Administrative Agen, it successors and assigns a security interest in, all and singular, of Waterton Parking Borrower's right, title and interest in and to the properties, rights, interests and privileges described in Granting Clauses I, II, III, IV, V, VI, VII, VIII and IX below, all of same being collectively referred to hercin as the "Mortgaged Property":

GRANTING CLAUSE I:

THE LAND located in Cook County, Illinois which is legally described on **Exhibit A** attached hereto and made a part hereof (the "**Land**");

GRANTING CLAUSE II:

TOGETHER WITH all buildings, structures and improvements of every nature whatsoever now or hereafter situated on the Land, including all extensions, additions,

improvements, betterments, renewals, substitutions and replacements to or for any such buildings, structures and improvements and all of the right, title and interest of the Waterton Parking Borrower now or hereafter acquired in and to any of the foregoing, including without limitation those certain improvements to be constructed on the Land in accordance with the Loan Agreement (the "Improvements");

GRANTING CLAUSE III:

TOGETHER WITH all easements, rights of way, strips and gores of land, streets, ways, alleys, sidewalks, vaults, passages, sewer rights, waters, water courses, water drainage and reservoir rights and powers (whether or not appurtenant), all estates, rights, titles, interests, privileges, liberties, tenements, hereditaments, easements, franchises, appendages and appurtenances whatsoever, in any way belonging, relating or appertaining to the Land or the Improvements, whether now owned or hereafter acquired by the Waterton Parking Borrower, including without 'in itation all existing and future mineral, oil and gas rights which are appurtenant to or which have been used in connection with the Land, all existing and future water stock relating to the Land or the Improvements, all existing and future share of stock respecting water and water rights pertaining to the Land or the Improvements or other evidence of ownership thereof, and the reversions and remainders thereof (the "Appurtenant Rights");

GRANTING CLAUSE IV:

TOGETHER WITH all machinery, apparatus, equipment, fittings and fixtures of every kind and nature whatsoever, and all furniture furnishings and other personal property now or hereafter owned by the Waterton Parking Borrower and forming a part of, or used or obtained for use in connection with, the Land or the Improvements or any present or future operation, occupancy, maintenance or leasing thereof; including, but without limitation, any and all heating. ventilating and air conditioning equipment and systems, artennae, appliances, apparatus, awnings, basins, bathtubs, bidets, boilers, bookcases, cabinets, carpets, communication systems, coolers, curtains, dehumidifiers, dishwashers, disposals, doors, draper, draper, rods, dryers, ducts, dynamos, elevators, engines, equipment, escalators, fans. fittings, floor coverings, furnaces, furnishings, furniture, hardware, heaters, humidifiers, incinerators, lighting, machinery, motors, ovens, pipes, plumbing and electric equipment, pool equipment, pumps, radiators, ranges, recreational facilities and equipment, refrigerators, screens, sprinklers, stokers, stoves, shades, shelving, sinks, security systems, toilets, ventilators, wall coverings, washers, windows, window covering, wiring and all extensions, renewals or replacements thereof or substitutions therefor or additions thereto, whether or not the same are or shall be attached to the Land or the Improvements in any manner (collectively, the "Fixtures"); it being agreed that all of said property owned by the Waterton Parking Borrower and placed on the Land or on or in the Improvements (whether affixed or annexed thereto or not) shall, so far as permitted by law, conclusively be deemed to be real property and conveyed hereby for purposes of this Mortgage;

GRANTING CLAUSE V:

TOGETHER WITH the following:

All personal property of every nature whatsoever now or hereafter owned by Waterton Parking Borrower or used in connection with the Land or the improvements thereon, including all extensions, additions, improvements, betterments, renewals, substitutions and replacements thereof and all of the right, title and interest of Waterton Parking Borrower in and to any such personal property together with the benefit of any deposits or payments now or hereafter made on such personal property by Waterton Parking Borrower or on its behalf, including without limitation, any and all Goods, Investment Property, Instruments, Chattel Paper, Documents, Letter of Credit Rights, Accounts, Deposit Accounts (other than escrow accounts for the benefit of purchasers under the Sale Contracts), Commercial Tort Claims and General Intangibles, each as defined in the Uniform Commercial Code of the State of Illinois, of Waterton Parking Borrower;

All proceeds of the foregoing, including, without limitation, all judgments, awards of damages and sendements hereafter made resulting from condemnation proceeds or the taking of the Land or improvements thereon or any portion thereof under the power of eminent domain, any proceeds of any policies of insurance, maintained with respect to the Land or improvements thereon or proceeds of any sale, option or contract to sell the Land or improvements thereon or any portion thereof;

Any and all additions and accessories to all of the foregoing and any and all proceeds (including proceeds of insurance, entirent domain or other governmental takings and tort claims), renewals, replacements and subsociations of all of the foregoing;

All of the books and records pertaining to the foregoing (all of the foregoing being referred to as the "Personal Property");

GRANTING CLAUSE VI:

TOGETHER WITH all right, title and interest which the Waterton Parking Borrower hereafter may acquire in and to all leases and other agreements now or hereafter entered into for the occupancy or use of the Land, the Appurtenant Rights, the Improvements, the Fixtures and the Personal Property or any portion thereof, whether written or oral (herein collectively referred to as the "Leases"), and all rents, issues, incomes and profits in any manner arising thereunder (herein collectively referred to as the "Rents"), and all right, title and interest which the Waterton Parking Borrower now has or hereafter may acquire in and to any bank accounts, security deposits, and any and all other amounts held as security under the Leases, reserving to the Waterton Parking Borrower any statutory rights;

GRANTING CLAUSE VII:

TOGETHER WITH any and all Awards and Insurance Proceeds, as each are hereinafter respectively defined, or proceeds of any sale, option or contract to sell the Mortgaged Property or any portion thereof (provided that no right, consent or authority to sell the Mortgaged Property or any portion thereof shall be inferred or deemed to exist by reason hereof); and the Waterton Parking Borrower hereby authorizes, directs and empowers the Administrative Agent, at its option, on the Waterton Parking Borrower's behalf, or on behalf of the successors or assigns of the Waterton Parking Borrower, to adjust, compromise, claim, collect and receive such proceeds;

to give acquittances therefor; and, after deducting expenses of collection, including reasonable attorneys' fees, costs and disbursements, to apply the Net Proceeds, as hereinafter defined, to the extent not utilized for the Restoration of the Mortgaged Property as provided in Section 7 or Section 8 hereof, to payment of the Debt, notwithstanding the fact that the same may not then be due and payable or that the Debt is otherwise adequately secured; and the Waterton Parking Borrower agrees to execute and deliver from time to time such further instruments as may be requested by the Administrative Agent to confirm such assignment to the Administrative Agent of any such proceeds;

GRANTING CLAUSE VIII:

TCGF THER WITH all rights reserved to or granted to the developer or declarant under the provisions of any (i) declaration of restrictive covenants and easements affecting the Land or the Mortgaged Property, or (ii) declaration of condominium ownership (the "Declaration") for the institution of a regime of condominium ownership affecting the Land or the Mortgaged Property or otherwise granted to the developer pursuant to the provisions of the Illinois Condominium Property Act, 765 ILCS 605/1 et. seq. (the "Condominium Act") in effect from time to time;

GRANTING CLAUSE IX:

TOGETHER WITH all estate, right, title and interest, homestead or other claim or demand, as well in law as in equity, which the Waterton Parking Borrower now has or hereafter may acquire of, in and to the Mortgaged Property, or any part thereof, and any and all other property of every kind and nature from time to vine hereafter (by delivery or by writing of any kind) conveyed, pledged, assigned or transferred as and for additional security hereunder by the Waterton Parking Borrower or by anyone on behalf of the Waterton Parking Borrower to Administrative Agent;

TO HAVE AND TO HOLD the Mortgaged Property, unto the Administrative Agent, and its successors and assigns, IN FEE SIMPLE, forever; subject, however, to those encumbrances which the Administrative Agent has approved in the Loan Agreement of otherwise approved in writing (the "Permitted Encumbrances");

UPON CONDITION that, subject to the terms hereof so long as no Event of Default exists hereunder, the Waterton Parking Borrower shall be permitted to possess and use the Mortgaged Property;

SUBJECT to the covenants and conditions hereinafter set forth.

PROVIDED, NEVERTHELESS, that if (i) the Waterton Parking Borrower shall pay and perform in full when due the Debt and shall duly and timely perform and observe all of the covenants and conditions herein and in the other Loan Documents required to be performed and observed by the Waterton Parking Borrower, and (ii) the Administrative Agent shall have no further obligation to make any further disbursements of the Loan to or for the benefit of Waterton Parking Borrower under the provisions of the Loan Agreement, then the Administrative Agent shall execute and deliver to the Waterton Parking Borrower such

instruments as may be reasonably requested by the Waterton Parking Borrower which are sufficient to release this Mortgage.

THE WATERTON PARKING BORROWER FURTHER COVENANTS AND AGREES AS FOLLOWS:

- 1. <u>Representations of Waterton Parking Borrower</u>. Waterton Parking Borrower hereby represents and warrants to the Administrative Agent as follows:
 - (a) Waterton Parking Borrower (i) is a limited liability company duly formed and validly existing under the laws of the State of Delaware and the State of Illinois and has complied with all conditions prerequisite to its doing business in the State of Illinois; (ii) has the power and authority to own its property and to carry on its business as now being conducted; (iii) is qualified to do business in every jurisdiction in which the nature of its business or its property makes such qualification necessary; and (iv) is in compliance with all laws, regulations, ordinances and orders of public authorities applicable to it.
 - (b) The Waterton Parking Borrower has good and marketable title to an indefeasible fee simple estate in the Mortgaged Property, subject to no liens, charges or encumbrances, other than the Permitted Encumbrances; that it has good, right and lawful authority to mortgage the Mortgaged Property in the manner and form herein provided; that this Mortgage is and shall remain a valid and enforceable lien on the Mortgaged Property subject only to the Permitted Encumbrances; that Waterton Parking Borrower and its successors and assigns shall defend the same and the priority of this lien forever against the lawful claims and demands of all persons whomsoever, and that this covenant shall not be extinguished by any foreclosure here of but shall run with the Land.
 - (c) As of the date hereof, there has been no material change in the financial condition of Waterton Parking Borrower or any guarantor of the Notes from that set forth in Waterton Parking Borrower's most recent financial statement, and, to the best of Waterton Parking Borrower's knowledge, the financial statements of such guarantor, and the financial information contained therein was true and correct on the date the statements were issued and there has been no material adverse change as of the date hereof.
 - (d) There are no suits or proceedings pending, or to the knowledge of Waterton Parking Borrower, threatened against or affecting Waterton Parking Borrower, which, if adversely determined, would have a material adverse effect on the financial condition or business of Waterton Parking Borrower or its ability to perform its obligations under this Mortgage or any of the other Loan Documents executed by it, and there are no proceedings by or before any court, governmental commission, board, bureau, or other administrative agency pending or, to the knowledge of Waterton Parking Borrower, threatened against Waterton Parking Borrower, which, if adversely determined, would have a material adverse effect on the financial condition or business of Waterton Parking Borrower or its ability to perform its obligations under this Mortgage or any of the other Loan Documents executed by it.

- (e) The Mortgaged Property complies with all requirements of law, municipal ordinances and restrictions and covenants of record with respect to the Mortgaged Property and the use thereof.
- (f) The Waterton Parking Borrower has and shall maintain title to the collateral for the Loan, including any additions or replacements thereto, free of all security interests, liens and encumbrances, other than the security interest hereunder.
- (g) No person who owns twenty percent (20.00%) or more of the equity interests in the Waterton Parking Borrower, or otherwise controls the Waterton Parking Borrower or any of its subsidiaries, is listed on the Specially Designated Nationals and Blocked Person List or other similar lists maintained by the Office of Foreign Assets Control ("OFAC"), the Department of the Treasury or included in any Executive Orders, and the proceeds of the Loan will not violate any of the foreign asset control regulations of OFAC or any enabling statute or Executive Order relating thereto.
- (h) The Waterton Parking Borrower is able to pay its debts as such debts become due, and has capital sufficient to carry on its present businesses and transactions and all businesses and transactions in which it is about to engage. The Waterton Parking Borrower (i) is not bankrupt or insolvent, (ii) has not made an assignment for the benefit of its creditors, (iii) has not bad a trustee or receiver appointed, (iv) has not had any bankruptcy, reorganization or insolvency proceedings instituted by or against it, or (v) shall not be rendered insolvent by its execution, delivery or performance of the Loan Documents or by the transactions contemplated thereunder.

2. Waterton Parking Borrower's Covenants.

- (a) <u>Payment of Debt</u>. The Waterton Parking Borrower shall, prior to the expiration of any grace period: (i) pay the Debt when due, and (ii) duly and punctually perform and observe all of the covenants and conditions to be performed or observed by the Waterton Parking Borrower as provided in the Notes, five Loan Agreement, this Mortgage and the other Loan Documents.
- (b) Repair/Maintenance. The Waterton Parking Borrower shall (i) promptly repair, restore, replace or rebuild any portion of the Mortgaged Property which may be damaged or destroyed; (ii) keep the Mortgaged Property in good condition and repair, free from waste; (iii) pay all operating costs and expenses of the Mortgaged Property when due; (iv) comply with all legal requirements applicable to all or any portion of the Mortgaged Property, or the use and occupancy, thereof (subject to the right of the Waterton Parking Borrower to contest the enforceability or applicability of any such legal requirements in good faith, diligently and at its expense by appropriate proceedings which shall not subject the Waterton Parking Borrower or the Administrative Agent to any risk of civil or criminal liability and which shall operate during the pendency thereof to prevent the imposition or foreclosure of any lien upon, or any interference with the availability, use or occupancy of, the Mortgaged Property or any part thereof), and observe and comply with any conditions and requirements necessary to preserve and extend any and all rights, licenses, permits (including without limitation zoning

variances, special exceptions and nonconforming uses), privileges, franchises and concessions that are applicable to all or any portion of the Mortgaged Property or the use and occupancy thereof; (v) refrain from any action, and correct any condition known to the Waterton Parking Borrower, which would materially increase the risk of fire or other hazard to the Mortgaged Property or any portion thereof; and (vi) cause the Mortgaged Property to be managed in a competent and professional manner.

- Alteration of Mortgaged Property. Without the prior written consent of the Administrative Agent, the Waterton Parking Borrower shall not cause, suffer or permit (i) any material alteration of the Mortgaged Property, except as required by any applicable legal requirement or in connection with the proposed development of the Mongaged Property as a residential condominium project pursuant to the Loan Agreement, or as otherwise contemplated by the Loan Agreement; (ii) any change in the zoning cirss fication or intended use or occupancy of the Mortgaged Property, including without limi at on any change which would increase any fire or other hazard, unless such change in zoning or intended use is required in connection with the proposed development of the Mortgaged Property as a residential condominium project pursuant to the Loan Agreement; (ii) any change in the identity of the Waterton Parking Borrower or the person or entity responsible for managing the Mortgaged Property except as otherwise expressly permitted in the Loan Documents; or (iv) any material modification of the licenses, permits, privileges, franchises, covenants, conditions or declarations of use applicable to the Mortgaged Property, except as required to operate the Mortgaged Property in the manner required hereunder or in connection with the development of the Mortgaged Property as a residential conforminium project in accordance with the Loan Agreement.
- (d) Operating Agreement of Waterton Parking Borrower. The Limited Liability Agreement of the Waterton Parking Borrower shall not, without the prior written consent of the Administrative Agent, be amended or modified if such amendment or modification could have a material adverse effect on the Waterton Parking Borrower's ability to perform its obligations under any of the Loan Documents, nor shall any member or manager of the Waterton Parking Borrower (unless expressly permitted under Section 12 of this Mortgage) be released or discharged from its or his (bligations under the Waterton Parking Borrower's Operating Agreement, nor shall any member of the Waterton Parking Borrower transfer (unless expressly permitted under Section 12 of this Mortgage), pledge or encumber in any way any member interest in the Water or Parking Borrower or the right to receive income or proceeds from the Waterton Parking Borrower. At all times prior to the repayment of the Loan, Belgravia Group, Ltd. ("Manager's Manager") shall be the sole manager of Belgravia Wabash Condominium LLC, an Illinois limited liability company ("Manager"), Manager shall be the sole Manager of the Wabash Condominium Borrower, Wabash Condominium Borrower shall be the sole member of Waterton Parking Borrower, and David W. Ruttenberg and/or Alan D. Lev shall be the only shareholders of Manager's Manager, currently, but shall be permitted to issue or sell shares to Jonathan W. McCulloch and/or David T. Goldman.
- (e) <u>Continuing Existence.</u> The Waterton Parking Borrower, without the prior written consent of the Administrative Agent, shall not (i) permit itself to be dissolved or

its existence terminated, or (ii) amend or modify its organizational documents if such amendment or modification could have a material adverse effect on (A) the Waterton Parking Borrower's ability to perform its obligations under any of the Loan Documents, or (B) the validity or priority of the Administrative Agent's liens or security interests under the Loan Documents. Notwithstanding the foregoing to the contrary, any amendment to the organizational documents of the Waterton Parking Borrower which are made to effectuate a "Permitted Transfer" (as defined in Section 12(a) below, shall not be deemed a violation of this subsection 2(e).

- (f) <u>Compliance with Laws</u>. The Waterton Parking Borrower shall comply with all regulations, rules, ordinances, statutes, orders and decrees of any governmental authority or court applicable to the Waterton Parking Borrower or to the Mortgaged Property or any part thereof.
- (g) Operating and Reserve Accounts. The Waterton Parking Borrower shall maintain the operating, escrow (except escrow accounts established to hold earnest money deposits). Esserve and other accounts, if any, for the Mortgaged Property with the Administrative Agent and pledge the same to the Administrative Agent as additional security for the Loan.

3. Liens, Contest and Defence of Title.

- (a) The Waterton Parking Eorrower shall not create or suffer or permit any lien, charge or encumbrance to attach to or be filed against the Mortgaged Property or any part thereof, or interest thereon, or any other rights and properties conveyed, mortgaged, transferred and granted hereunder (except for Permitted Encumbrances), whether such lien, charge or encumbrance is on a parity, inferior or superior to the lien of this Mortgage, including liens for labor or materials with respect to the Mortgaged Property ("Mechanic's Liens").
- Notwithstanding paragraph (a) of this Section, the Waterton Parking Borrower may in good faith and with reasonable diligence contest the validity or amount of any Mechanic's Liens and defer payment and discharge thereof during the pendency of such contest, provided that: (i) such contest shall prevent the sale or forfeiture of the Mortgaged Property, or any part thereof or any interest therein, to satisfy such Mechanic's Liens and shall not result in a forfeiture or impairment of the ken of this Mortgage; and (ii) within ten (10) days after the Waterton Parking Borrower has been notified of the filing of any such Mechanic's Liens, the Waterton Parking Borrower shall have notified the Administrative Agent in writing of the Waterton Parking Borrower's intention to contest such Mechanic's Liens, or to cause such other party to contest such Mechanic's Liens, and shall have obtained a title insurance endorsement over such Mechanic's Liens in form and substance reasonably satisfactory to the Administrative Agent, insuring the Administrative Agent against loss or damage by reason of such Mechanic's Liens; provided that in lieu of such title insurance endorsement the Waterton Parking Borrower may deposit and keep on deposit with the Administrative Agent (or such depositary as may be designated by the Administrative Agent) a sum of money sufficient, in the judgment of the Administrative Agent, to pay in full such Mechanic's

Liens and all interest thereon. Any such deposits are to be held without any allowance of interest and may be used by the Administrative Agent in its sole discretion to protect the priority of this Mortgage. In case the Waterton Parking Borrower shall fail to maintain such title insurance or deposit, or to prosecute or cause the prosecution of such contest with reasonable diligence, or to pay or cause to be paid the amount of the Mechanic's Lien, plus any interest finally determined to be due upon the conclusion of such contest; then the Administrative Agent may, at its option, apply any money and liquidate any securities then on deposit with the Administrative Agent (or other depositary designated by the Administrative Agent) in payment of or on account of such Mechanic's Liens, or that part thereof then unpaid, together with all interest thereon according to any written bill, notice or statement, without inquiring into the amount, validity or enforceability thereof. If the amount of money so deposited shall (in Administrative Agent's reasonable judgment) be insufficient for the payment in full of such Mechanic's Liens, together with all interest thereon, then the Waterton Parking Borrower shall forthwith, upon demand, deposit with the Administrative Agent (or other depositary designated by the Administrative Agent's reasonable judgment, when added to the funds then on deposit with Administrative Agent) be necessary to make such payment in full (or such other security as shall be reasonably satisfactory to Administrative Agent). If a Mechanic's Lien claim is ultimately resolved in the claimant's favor, then the monies so deposited shall be applied in full payment of such Mechanic's Lien or that part thereof then unpaid, together with all interest thereon (provided no Event of Default shall then exist) when the Administrative Agent has been furnished with satisfactory evidence of the amount of payment to be made. Any excess monies remaining on deposit with the Administrative Agent (or other depositary) under this Section 3(b) shall be paid to the Waterton Parking Borrower, provided that no Event of Default shall then exist,

(c) If the lien and security interest of the Administrative Agent in or to the Mortgaged Property, or any part thereof, shall be endangered or shall be attacked, directly or indirectly, the Waterton Parking Borrower shall immediately notify the Administrative Agent and shall appear in and defend any action or proceeding purporting to affect the Mortgaged Property, or any part thereof, and shall file and prosecute such proceedings and take all actions necessary to preserve and protect such title, lien and security interest in and to the Mortgaged Property.

4. Payment and Contest of Taxes.

(a) The Waterton Parking Borrower shall pay or cause to be paid before delinquent and before any penalty attaches, all general and special taxes, assessments, water charges, sewer charges, and other fees, taxes, charges and assessments of every kind and nature whatsoever levied or assessed against the Mortgaged Property, or any part thereof, or any interest therein, or any income or revenue therefrom, or any obligation or instrument secured hereby, and all installments thereof (collectively, the "Taxes"), on or before the date such Taxes are due, except to the extent Administrative Agent makes payments with Waterton Parking Borrower's deposits under Section 26 hereof; and the Waterton Parking Borrower shall discharge any claim or lien relating to Taxes upon the Mortgaged Property. The Waterton Parking Borrower shall provide the

Administrative Agent with copies of paid receipts for Taxes, if requested by the Administrative Agent, within ten (10) days after being requested to do so by the Administrative Agent.

(b) Notwithstanding paragraph (a) of this Section 4, the Waterton Parking Borrower may, in good faith and with reasonable diligence, contest or cause to be contested the validity or amount of any such Taxes, provided that: (i) no Event of Default has occurred; (ii) such proceeding shall stay the collection of the applicable Taxes from Waterton Parking Borrower and from the Mortgaged Property or Waterton Parking Borrower shall have paid all of the applicable Taxes under protest, (iii) such proceeding shall be permitted under and be conducted in accordance with the provisions of any other instancent to which Waterton Parking Borrower is subject and shall not constitute a default thereunder, (iv) neither the Mortgaged Property nor any part thereof or interest therein will be in danger of being sold, forfeited, terminated, cancelled or lost so long as the contest is being pursued, and (v) Waterton Parking Borrower shall have deposited with Administrative Agent adequate reserves for the payment of the applicable Taxes together with all interest and penalties thereon, unless Waterton Parking Borrower has paid all of the applicable Taxes under protest, or Waterton Parking Borrower shall have furnished such other security as may be accepted by Administrative Agent, in its sole and absolute discretion, to insure the payment of any contested Taxes, together with all interest and penalties thereon. If the Waterton Parking Borrower fails to prosecute such contest with reasonable diligence or fails to maintain sufficient funds as hereinabove provided, the Administrative Agent may, at its option, liquidate any securities and apply the monies then on deposit with the Administrative Agent (or other depositary), in payment of, or on account of, such Taxes, or any portion thereof then unpaid, including all penalties and interest thereon according to any written bill, notice or statement, without inquiry as to the amount, validity or enforceability thereof. If the amount of money and any such security so deposited shall (in the Administrative Agent's reasonable judgment) at any time be insufficient for the payment in full of such Taxes, together with all penalties and interest which are or might become due thereon, the Waterton Parking Borrower shall forthwith, upon demand, either deposit with the Administrative Agent (or other depositary designated by the Administrative Agent) a sum (or such other security as shall be reasonably satisfactory to the Administrative Agent) which when added to the funds then on deposit, shall (in the Administrative Agent's reasonarle judgment) be sufficient to make such payment in full, or, if the Administrative Agent (or other depositary) has applied funds so deposited on account of such Taxes, restore such deposit to an amount satisfactory to the Administrative Agent. After final disposition of such contest and upon the Waterton Parking Borrower's written request and delivery to the Administrative Agent of an official bill for such Taxes, the Administrative Agent (or other depositary) shall liquidate any securities and apply the monies, if any, then on deposit under this Section 4 to the payment of such Taxes or that part thereof then unpaid and the balance, if any, in excess of the amount required to be on deposit with the Administrative Agent (or other depositary) under Section 26 hereof shall be refunded to the Waterton Parking Borrower after such final disposition, provided that no Event of Default shall then exist.

5. Change in Tax Laws.

- (a) If, by the laws of the United States of America, or of any state or municipality having jurisdiction over the Administrative Agent, the Waterton Parking Borrower or the Mortgaged Property, any tax is imposed or becomes due in respect of the Notes or this Mortgage (excluding income, excise or franchise taxes imposed upon the Administrative Agent, except as provided in Section 5(c) below), or any liens on the Mortgaged Property created thereby, then the Waterton Parking Borrower shall pay such tax in the manner required by such law.
- If any law, statute, rule, regulation, order or court decree effects a ded ction from the value of the Mortgaged Property for the purpose of taxation by creating any lien thereon, or imposing upon the Administrative Agent any liability for the payment of all or any part of the Taxes required to be paid by the Waterton Parking Borrower, or changing in any way the laws relating to the taxation of mortgages or deeds of trusts or doors secured by mortgages or deeds of trust or the interest of the Administrative Agent in the Mortgaged Property, or the manner of collection of Taxes so as to adversely affect this Mortgage, the Debt, or the Administrative Agent, then, and in any such event, the Waterton Parking Borrower, upon demand by the Administrative Agent, shall pay such Tax is, or reimburse the Administrative Agent therefor on demand. unless the Administrative Apent determines, in the Administrative Agent's reasonable judgment, that such payment or combursement by the Waterton Parking Borrower is unlawful or that the payment might, in the Administrative Agent's judgment, constitute usury or render the Debt wholly or partially usurious; in which event the Administrative Agent may elect to declare the Debt to be due and payable within the lesser of (i) thirty (30) days after written notice, or (ii) such sooner period as may be required to ensure compliance by Administrative Agent with Applicable Law.
- (c) Nothing contained herein shall require the Waterton Parking Borrower to pay any income, franchise or excise tax imposed upon the Administrative Agent, excepting only such income, franchise or excise tax which may be levied against the income of the Administrative Agent as a complete or partial substitute for Taxes required to be paid by the Waterton Parking Borrower hereunder.
- 6. <u>Insurance Coverage</u>. For so long as this Mortgage is in effect, Waterton Parking Borrower shall continuously maintain insurance in accordance with the following provisions:
 - (a) Waterton Parking Borrower shall obtain and maintain, or cause the 403 Wabash Condominium Association (the "Association") to obtain and maintain, at all times during the term of the Loan and so long as Waterton Parking Borrower appoints a majority of the board of directors of the Association the insurance required by Administrative Agent pursuant to **Exhibit B** attached hereto. In addition, Waterton Parking Borrower shall cause Administrative Agent to be named as a named insured under the insurance policies required by Administrative Agent and Administrative Agent shall be identified in each policy as follows: CIBC Bank USA, its successors and/or assigns as their respective interests may appear. Waterton Parking Borrower shall provide Administrative Agent with evidence of all such insurance required hereunder.

- (b) The policies of insurance to be obtained and maintained by Waterton Parking Borrower under the provisions of this Mortgage shall be issued by responsible insurance carriers with a Best's rating of no less than A/VII, licensed to do business in the State of Illinois, who are acceptable to Administrative Agent and shall be in such form and with such endorsements (including a mortgagee clause in favor of Administrative Agent), waivers and deductibles (in no event to exceed \$25,000) as Administrative Agent shall designate or approve. Without limitation on the foregoing:
 - (i) All policies shall name Waterton Parking Borrower as the insured, and (with the exception of policies for workmen's compensation insurance) shall name Administrative Agent as mortgagee and as an additional insured (under a standard non-contributing mortgagee protection clause, in form reasonably satisfactory to Administrative Agent, attached to such policy or policies whenever applicable, and providing, among other matters, that all insurance proceeds shall be paid to Administrative Agent).
 - (ii) All policies shall contain: (1) the agreement of the insurer to give Administrative Agent at least 30 days' written notice prior to cancellation or expiration of cr change in such policies, or any of them; (2) a waiver of subrogation rights against Administrative Agent and, if available Waterton Parking Borrower; (3) an agreement that such policies are primary and non-contributing with any insurance that may be carried by Administrative Agent: (4) a statement that the insurance shall not be invalidated should any insured waive in writing prior to a lose any or all right of recovery against any party for loss accruing to the property described in the insurance policy; and (5) if obtainable, a provision that no act or onission of Waterton Parking Borrower shall affect or limit the obligation of the insurance carrier to pay the amount of any loss sustained. As of the date hereof, and subject to any changes in such requirements which Administrative Agent may in its discretion, make from time to time pursuant to its rights under this Section 6, each policy of property insurance hereunder shall contain a lender's loss payable endorsement, lender clause, or other non-contributory mortgagee clause of similar form and substance acceptable to Administrative Agent in favor of Administrative Agent as a mortgagee.
- (c) Concurrently herewith, Waterton Parking Borrower shall deliver to Administrative Agent original policies or certificates with premiums prepaid evidencing the insurance required hereunder. Waterton Parking Borrower shall procure and pay for renewals of such insurance or shall cause the procurement and payment from time to time before the expiration thereof, and Waterton Parking Borrower shall deliver to Administrative Agent such original renewal policies or certificates with premiums prepaid at least 30 days before the expiration of any existing policy.
- (d) Waterton Parking Borrower, for itself, and on behalf of its insurers, hereby releases and waives any right to recover against Administrative Agent on any liability for: damages for injury to or death of persons; any loss or damage to property, including the property of any occupant of the Mortgaged Property; any loss or damage to buildings

or other improvements comprising the Mortgaged Property; any other direct or indirect loss or damage caused by fire or other risks, which loss or damage is or would be covered by the insurance required to be carried hereunder by Waterton Parking Borrower, or is otherwise insured; or claims arising by reason of any of the foregoing, except to the extent caused solely by the gross negligence or willful misconduct of Administrative Agent, respectively.

- (e) Administrative Agent shall not, by reason of accepting, rejecting, obtaining or failing to obtain insurance, incur any liability for (i) the existence, non-existence, form, amount or legal sufficiency thereof, (ii) the solvency or insolvency of any insurer, or (iii) the payment of losses. All insurance required hereunder or carried by Walerton Parking Borrower's sole cost and expense. Waterton Parking Borrower shall deliver to Administrative Agent receipts so his factory to Administrative Agent evidencing full prepayment of the premiums therefor, excert to the extent Administrative Agent makes payments with Waterton Parking Borrowe's deposits under the Loan Agreement or Section 26 hereof (for the periods and payments so covered by such payments). In the event of foreclosure on, or other transfer of title in lieu of foreclosure of, the Mortgaged Property, all of Waterton Parking Borrower's interest in and to any and all insurance policies in force shall pass to Administrative Agent, or the transferee or purchaser as the case may be, and Administrative Agent is hereby irrevocably authorized to assign in Waterton Parking Borrower's name to such purchaser or transferee all such policies, which may be amended or rewritten to show the interest of such purchaser or transferee.
- WATERTON PARKING BORROWER IS HEREBY NOTIFIED (f) PURSUANT TO THE ILLINOIS COLLAFERAL PROTECTION ACT (815 ILCS 180/1 ET. SEQ.) THAT UNLESS WATERTON FARKING BORROWER PROVIDES ADMINISTRATIVE AGENT WITH EVIDENCE OF THE INSURANCE COVERAGE AGREEMENT, ADMINISTRATIVE AGENT REQUIRED BY THIS REQUIRED INSURANCE AT WATERTON **PURCHASE** THE BORROWER'S EXPENSE TO PROTECT ADMINISTRATIVE AGENT'S INTEREST IN THE MORTGAGED PROPERTY. THIS INSURANCE MAY, BUT NEED NOT, PROTECT WATERTON PARKING BORROWER'S INTERESTS. THE COVERAGE THAT ADMINISTRATIVE AGENT PURCHASES MAY NOT PAY ANY CLAIM THAT WATERTON PARKING BORROWER MAKES OR ANY CLAIM THAT IS MADE AGAINST WATERTON PARKING BORROWER IN CONNECTION WITH THE MORTGAGED PROPERTY. WATERTON PARKING BORROWER MAY LATER CANCEL ANY INSURANCE PURCHASED BY ADMINISTRATIVE AGENT, BUT ONLY AFTER PROVIDING ADMINISTRATIVE AGENT WITH EVIDENCE THAT WATERTON PARKING BORROWER HAS OBTAINED INSURANCE AS REQUIRED BY THIS MORTGAGE. IF ADMINISTRATIVE AGENT PURCHASES INSURANCE FOR THE MORTGAGED PROPERTY, WATERTON PARKING BORROWER WILL BE RESPONSIBLE FOR THE COSTS OF THAT INSURANCE, INCLUDING INTEREST AT THE DEFAULT RATE AND ANY OTHER CHARGES ADMINISTRATIVE AGENT MAY IMPOSE IN CONNECTION WITH THE PLACEMENT OF THE INSURANCE UNTIL THE EFFECTIVE DATE OF THE CANCELLATION OR THE EXPIRATION OF THE

INSURANCE. THE COSTS OF THE INSURANCE SHALL BE ADDED TO WATERTON PARKING BORROWER'S TOTAL OUTSTANDING BALANCE OR OBLIGATION AND SHALL CONSTITUTE ADDITIONAL DEBT. THE COSTS OF THE INSURANCE MAY BE MORE THAN THE COST OF INSURANCE WATERTON PARKING BORROWER MAY BE ABLE TO OBTAIN ON ITS OWN. ADMINISTRATIVE AGENT SHALL GIVE WATERTON PARKING BORROWER WRITTEN NOTICE OF ANY INSURANCE ADMINISTRATIVE AGENT BELIEVES IS NOT IN PLACE AS REQUIRED BY THIS MORTGAGE AND ADMINISTRATIVE AGENT'S INTENT TO PURCHASE SUCH INSURANCE. **ADMINISTRATIVE** AGENT SHALL THEREAFTER PURCHASE SUCH REQUIRED INSURANCE ONLY IF WATERTON PARKING BORROWER SHALL FAIL TO OBTAIN AND DELIVER EVIDENCE OF THE REQUIRED INSURANCE TO ADMINISTRATIVE AGENT WITHIN THREE (3) BUSINESS DAYS AFTER RECEIPT OF SUCH WRITTEN NOTICE.

(g) Approval by the Administrative Agent of any policies of insurance ("Policies") shall so be deemed a representation by the Administrative Agent as to the adequacy of coverage of such Policies or the solvency of the insurer.

7. Casualty Loss; Proceeds of Insurance.

- (a) The Waterton Farking Borrower will give the Administrative Agent prompt written notice of any loss or demage to the Mortgaged Property, or any part thereof, by fire or other casualty.
- In case of loss or damage covered by any one of the Policies in excess of \$200,000.00, the Administrative Agent is hereby authorized to settle and adjust any claim under such Policies (and after the entry of a decree of foreclosure, or a sale or transfer pursuant thereto or in lieu thereof, the decree creditor or such purchaser or transferee, as the case may be, are hereby authorized to settle and adjust any claim under such Policies) upon consultation with, but without requiring the consent of, the Waterton Parking Borrower; and the Administrative Agent shall, and is hereby authorized to, collect and receipt for any and all proceeds payable under such Policies in connection with any such loss (collectively, the "Insurance Proceeds"). Waterton Parking Borrower hereby irrevocably appoints Administrative Agent as its attorney-in-fact for the purposes set forth in the preceding sentence. Each insurance company is hereby authorized and directed to make payment (i) of 100% of all such losses (if such loss exceeds said amount) directly to Administrative Agent alone, and (ii) of 100% of all such losses (if such loss is less than or equal to said amount) directly to Waterton Parking Borrower alone, and in no case to Waterton Parking Borrower and Administrative Agent jointly. All reasonable costs and expenses incurred by the Administrative Agent in the adjustment and collection of any such Insurance Proceeds (including without limitation reasonable attorneys' fees and expenses) shall be so much additional Debt, and shall be reimbursed to the Administrative Agent upon demand or may be paid and deducted by the Administrative Agent from such Insurance Proceeds prior to any other application thereof. Administrative Agent shall not be responsible for any failure to collect any

Insurance Proceeds due under the terms of any policy regardless of the cause of such failure, other than the gross negligence or willful misconduct of Administrative Agent.

- (c) Net Insurance Proceeds received by the Administrative Agent under the provisions of this Mortgage or any instrument supplemental hereto or thereto or any policy or policies of insurance covering any improvements on the Mortgaged Property or any part thereof shall be applied by the Administrative Agent at its option, and subject to the Declaration and Subsection (d) below, as and for a prepayment on the Notes, without a prepayment fee (whether or not the same is then due or otherwise adequately secured), or shall be disbursed for restoration of such improvements ("Restoration"), in which event the Administrative Agent shall not be obligated to supervise Restoration work nor she'll the amount so released or used be deemed a payment of the indebtedness evidenced by the Notes. If Administrative Agent elects to permit the use of Insurance Proceeds to restore such improvements it may do all necessary acts to accomplish that purpose, including aurancing additional funds and all such additional funds shall constitute part of the Debt. If Administrative Agent elects to make the Insurance Proceeds available to Waterton Parking Sorrower for the purpose of effecting the Restoration, or, following an Event of Default, elects to restore such improvements, any excess of Insurance Proceeds above the amount necessar; to complete the Restoration shall be applied as and for a prepayment on the Notes, without a prepayment fee or premium. No interest shall be payable to Waterton Parking Porrower upon Insurance Proceeds held by Administrative Agent.
- Notwithstanding the previsions of subsection 7(c) above, subject to the (d) provisions of the Declaration, Administrative Agent agrees to allow the Insurance Proceeds to be disbursed for Restoration provided; (i) no Event of Default, and no default with which the passage of time or giving of notice would constitute and Event of Default, shall have occurred; (ii) Administrative Agent shall be satisfied in its sole and absolute discretion, that by expenditure of the Insurance Proceeds hereunder, the Mortgaged Property damaged or destroyed shall be fully restored within a reasonable period of time to the condition and value contemplated by this Mortgage and the Restoration Plans (as hereinafter defined), and all payments required under the Loan will continue to be paid as and when the same become due and payable; (iii) in Administrative Agent's good faith judgment, such repair and restoration can be completed in the ordinary course of business not later than the earlier of (a) six (6) months prior to the Maturity Date; (b) with respect to each individual Unit affected directly or indirectly by such casualty, at least fifteen (15) days prior to the "Required Completion Date" (as defined in the Sale Contract) for the sale of such Unit under a Purchase Contract; and (c) the outside date, if any, under any federal, state, county, municipal or other governmental statute, law, rule, order, regulation, ordinance, judgment, decree or injunction, or any permit, license, covenant, agreement, restriction or encumbrance; (iv) Administrative Agent shall have reasonably reviewed and approved Waterton Parking Borrower's plans and specifications for the repair and restoration of the Mortgaged Property involving costs in excess of \$200,000.00 (the "Restoration Plans"), Waterton Parking Borrower's architect and any general contractors, subcontractors and material suppliers employed to perform such work; (v) if so required by Administrative Agent in its reasonable discretion, all general contractors, all major subcontractors and material suppliers shall have supplied 100% performance

and completion bonds; (vi) if the net Insurance Proceeds available are insufficient for payment of the full cost of restoration or repair and the payments under the Loan during the completion period, as estimated by Administrative Agent, then Waterton Parking Borrower shall have deposited with Administrative Agent sufficient additional funds to insure payment of all such costs, or made arrangements acceptable to Administrative Agent for such sufficient additional funds; (vii) Waterton Parking Borrower shall provide evidence of the implementation of builder's risk coverage for the Mortgaged Property with coverage and in such amounts as Administrative Agent shall request and which otherwise complies with the insurance requirements set forth in Section 6 hereof; (viii) the provisions of Section 7.33 of the Loan Agreement continue to be satisfied, and (ix) Waterton Parking Borrower shall have satisfied such other conditions as Administrative Agent may in good faith determine to be appropriate.

Parking Borrover shall promptly commence and complete, or cause to be commenced and completed, with all reasonable diligence (taking into account any Force Majeure Delays of no more than sixty (60) days), the Restoration of the Mortgaged Property as nearly as possible to he same value, condition and character which existed immediately prior to such loss or damage in accordance with the Restoration Plans and in compliance with all legal requirements. Any Restoration shall be effected in accordance with procedures to be first submitted to and approved by the Administrative Agent in accordance with Section 9 hereof. The Waterton Parking Borrower shall pay all costs of such Restoration to the extent Insurance Proceeds are not made available or are insufficient.

8. Condemnation and Eminent Domain.

Any and all awards (the "Awards") in excess of \$100,000.00 heretofore or hereafter made or to be made to the Waterton Parking Borrower (or any subsequent owner of the Mortgaged Property, or any part thereof) by any governmental or other lawful authority for the taking, by condemnation or eminent domain, of all or any part of the Mortgaged Property (including any award from the United States government at any time after the allowance of a claim therefor, the ascertainment of the amount thereto, and the issuance of a warrant for payment thereof), are hereby assigned by the Waterton Parking Borrower to the Administrative Agent, which Awards the Administrative Agent is hereby authorized to collect and receive from the condemnation authorities, and the Administrative Agent is hereby authorized to appear in and prosecute, in the name of and on behalf of the Waterton Parking Borrower, any action or proceeding to enforce any such cause of action in which an award in excess of \$100,000.00 is sought and to make any compromise or settlement in connection therewith and to give appropriate receipts and acquittance therefor in the name and in behalf of the Waterton Parking Borrower. The Waterton Parking Borrower shall give the Administrative Agent prompt notice of the actual or threatened commencement of any condemnation or eminent domain proceedings affecting all or any part of the Mortgaged Property and shall deliver to the Administrative Agent copies of any and all papers served in connection with any such proceedings. All reasonable costs and expenses incurred by the Administrative Agent in the adjustment and collection of any such Awards (including without limitation

reasonable attorneys' fees and expenses) shall be so much additional Debt, and shall be reimbursed to the Administrative Agent from any Award prior to any other application thereof. The Waterton Parking Borrower further agrees to make, execute and deliver to the Administrative Agent, at any time upon request, free, clear, and discharged of any encumbrance of any kind whatsoever (other than Permitted Encumbrances), any and all further assignments and other instruments deemed necessary by the Administrative Agent for the purpose of validly and sufficiently assigning all Awards in excess of \$100,000.00 and other compensation heretofore and hereafter made to the Waterton Parking Borrower for any permanent taking, under any such proceeding.

- The proceeds of any Award received by the Administrative Agent under the provisions of this Mortgage or any instrument supplemental hereto shall be applied by the Administrative Agent at its option as and for a prepayment of the Debt, without a prepayment fee (whether or not the same is then due or otherwise adequately secured), or shall be discursed for Restoration of the Mortgaged Property, in which event the Administrative A sent shall not be obligated to supervise Restoration work nor shall the amount so release for used be deemed a payment of the Debt. If Administrative Agent elects to permit the use of the proceeds of an Award to restore such improvements it may do all necessary acts to accomplish that purpose, including advancing additional funds, all such additional funds to constitute part of the Debt. If Administrative Agent elects to make the proceeds of an Award available to Waterton Parking Borrower for the purpose of effecting the Restoration, or, realowing an Event of Default, elects to restore such improvements, any excess of such proceeds above the amount necessary to complete the Restoration shall be applied as and for a prepayment of the Debt, without a prepayment fee or premium. No interest shall be payacle to Waterton Parking Borrower upon such proceeds held by Administrative Agent.
- (c) Notwithstanding the provisions of Section 8(b) above, Administrative Agent agrees to allow the Award to be disbursed for Restoration provided: (i) all conditions to the use of casualty proceeds under Section 7(d) have been satisfied, and (ii) the condemnation, in the judgment of Administrative Agent, shall have no material adverse effect on the operation or value of the Mortgaged Property remaining after the condemnation is completed, and (iii) Waterton Parking Borrower shall have satisfied such other conditions as Administrative Agent may in good faith determine to be appropriate.
- (d) So long as any Debt shall be outstanding and unpaid, and whether or not Awards are available or sufficient therefor, the Waterton Parking Borrower shall promptly commence and complete, or cause to be commenced and completed, with all reasonable diligence the Restoration of the portion of the Mortgaged Property not so taken as nearly as possible to the same value, condition and character, which existed immediately prior to such taking in compliance with all legal requirements. Any Restoration of the Mortgaged Property involving costs in excess of \$100,000.00 shall be effected in accordance with Restoration Plans to be first submitted to and approved by the Administrative Agent as provided in Section 9 hereof. The Waterton Parking Borrower shall pay all costs of such Restoration to the extent the Award is not made available or is insufficient.

9. <u>Disbursement of Insurance Proceeds and Awards.</u>

- (a) All Insurance Proceeds and/or Awards received by the Administrative Agent as provided in Section 7 or Section 8 hereof shall, after payment or reimbursement therefrom of all reasonable costs and expenses (including without limitation reasonable attorneys' fees and expenses) incurred by the Administrative Agent in the adjustment and collection thereof (collectively, the "Net Proceeds"), shall be deposited with the Administrative Agent, or such other depositary as may be designated by the Administrative Agent, and applied as provided in this Section.
- (b) The Administrative Agent (provided Section 7(a) and Section 8(c) are not applicable) may elect to apply the Net Proceeds to prepayment of the Debt, whether then due or not. If the Debt is not prepaid in full, then the Net Proceeds shall be applied to the installments of principal and interest in the inverse order of maturity.
- (c) Al! Net Proceeds which are not applied to the payment of the Debt shall be applied to fund the payment of the costs, fees and expenses incurred for the Restoration of the Mortgaged Property as required under Section 7 or Section 8 hereof and such Net Proceeds shall be disbussed through the title company which has insured the lien of the Mortgage to complete the Restoration; provided that the Administrative Agent shall receive the following:
 - (i) Restoration Flans (unless the costs involved in such Restoration shall not exceed \$100,000.00), which shall be subject to the reasonable approval of the Administrative Agent prior to the commencement of the Restoration.
 - (ii) Such architect's and engineer's certificates, waivers of lien, contractor's sworn statements, payment and performance bonds (if applicable), title insurance endorsements, plats of survey, opinions of counsel and such other evidences of cost, payment and performance as the Administrative Agent may reasonably require and approve.
- (d) If the Waterton Parking Borrower shall fail to commence Restoration within thirty (30) days after the settlement of the claim involving less or damage to the Mortgaged Property, and diligently proceed to complete Restoration in accordance with the Restoration Plans and Applicable Laws (as defined in the Loan Agreement) or if any other Event of Default shall occur hereunder at any time (whether before or after the commencement of such Restoration), all or any portion of the Debt may be declared to be immediately due and payable and such Net Proceeds, or any portion thereof, then held, or subsequently received, by the Administrative Agent or other depositary hereunder may be applied, at the option and in the sole discretion of the Administrative Agent, to the payment or prepayment of the Debt in whole or in part, or to the payment and performance of such obligations of the Waterton Parking Borrower as may then be in default hereunder.

- (e) Any surplus which may remain out of such Net Proceeds after payment of all costs, fees and expenses of such Restoration shall be applied to prepayment of the Debt, without the payment of a prepayment fee or prepayment premium.
- 10. The Administrative Agent's Performance of the Waterton Parking Borrower's Obligations.
 - Upon the occurrence of an Event of Default hereunder, the Administrative Agent may, but without any obligation to do so, upon simultaneous notice to the Waterton Parking Borrower, make any payment or perform any act which the Waterton Parking Borrower is required to make or perform hereunder or under any other Loan Dor in ent (whether or not the Waterton Parking Borrower is personally liable therefor) in any form and lawful manner deemed expedient to the Administrative Agent, including without limitation, the right to enter into possession of the Mortgaged Property, or any portion there of and to take any action (including without limitation the release of any information regarding the Mortgaged Property, the Waterton Parking Borrower and the obligations secured hereby) which the Administrative Agent deems necessary or desirable in connection therewith, all at the sole cost and expense of the Waterton Parking Borrower. The Administrative Agent, in addition to any rights or powers granted or conferred hereunder but without any obligation to do so, may complete construction of, rent, operate, and manage the Mortgaged Property, or any part thereof, including payment of management fees and other operating costs and expenses, of every kind and nature in connection therewith, so that the Mortgaged Property shall be operational and usable for their intended purposes. All monies paid, and all reasonable expenses paid or incurred in connection therewith, including out not limited to reasonable costs of surveys, evidence of title, court costs and attorneys' fees and expenses and other monies advanced by the Administrative Agent to protect the Morigaged Property and the lien hereof, to complete construction of, rent, operate and manage the Mortgaged Property or to pay any such operating costs and expenses thereof or to keep the Mortgaged Property operational and usable for their intended purposes shall be so much additional Debt, and shall become immediately due and payable on demand, and with interest thereon at the Default Rate.
 - (b) The Administrative Agent, in making any payment, may do so according to any written bill, notice, statement or estimate, without inquiry into the amount, validity or enforceability thereof.
 - (c) Nothing contained herein shall be construed to require the Administrative Agent to advance or expend monies for any purpose mentioned herein, or for any other purposes.

11. Security Agreement.

(a) <u>Grant of Security Interest</u>. Waterton Parking Borrower hereby grants to Administrative Agent a security interest in the Personal Property to secure the Debt. This Mortgage constitutes a security agreement with respect to all Personal Property in which Administrative Agent is granted a security interest hereunder, and Administrative Agent

shall have all of the rights and remedies of a secured party under the Uniform Commercial Code of Illinois, as the same may be amended from time to time (the "Code") as well as all other rights and remedies available at law or in equity.

- Perfection. Waterton Parking Borrower hereby consents to any instrument that may be requested by Administrative Agent to publish notice or protect, perfect, preserve, continue, extend, or maintain the security interest and lien, and the priority thereof, of this Mortgage or the interest of Administrative Agent in the Mortgaged Property, including, without limitation, deeds of trust, security agreements, financing statements, continuation statements, and instruments of similar character, and Waterton Parking Borrower shall pay or cause to be paid (i) all filing and recording taxes and fees incident to each such filing or recording, (ii) all expenses, including without limitation, actual artorneys' fees and costs (of both in house and outside counsel), incurred by Administrative Agent in connection with the preparation and acknowledgement of all such instruments, and (iii) all federal, state, county and municipal stamp taxes and other taxes, duties, imposts, assessments, and charges arising out of or in connection with the delivery of such instruments. Waterton Parking Borrower hereby consents to, and hereby ratifies, the filing of any financing statements relating to the Loan made prior to the date Waterton Parking Borrower hereby irrevocably constitutes and appoints Administrative Agent as the attorney-in-fact of Waterton Parking Borrower, to file with the appropriate filing office any such instruments. In addition, Waterton Parking Borrower hereby authorizes Administrative Agent to cause any financing statement or fixture filing to be filed or recorded without the necessity of obtaining the consent of Waterton Parking Borrower.
- (c) <u>Place of Business</u>. Watertor, Parking Borrower maintains its chief executive office as set forth as the address of Waterton Parking Borrower in <u>Section 31</u> below, and Waterton Parking Borrower will notify Administrative Agent in writing of any change in its place of business within five (5) days of such change.
- (d) <u>Fixture Filing</u>. This Mortgage is intended to be a financing statement within the purview of Section 9-502(b) of the Code and will be recorded as a "fixture filing" in accordance with the Code.
- (e) Representations and Warranties. The Waterton Parking Borrower represents and warrants that: (i) the Waterton Parking Borrower is the record owner of the Mortgaged Property; (ii) the Waterton Parking Borrower's chief executive office is located in the State of Illinois; (iii) the Waterton Parking Borrower's state of organization is the State of Illinois; (iv) the Waterton Parking Borrower's exact legal name is as set forth on Page 1 of this Mortgage; (v) the Waterton Parking Borrower's organizational identification number is 00373869; (vi) Waterton Parking Borrower is the owner of the Personal Property subject to no liens, charges or encumbrances other than the lien hereof, (vii) the Personal Property will not be removed from the Mortgaged Property without the consent of the Administrative Agent, and (viii) no financing statement covering any of the Personal Property or any proceeds thereof is on file in any public office except pursuant hereto.

- 12. <u>Restrictions on Transfer.</u> For the purpose of protecting the Administrative Agent's security, and keeping the Mortgaged Property free from subordinate financing liens, and subject to the provisions described in Section 2(d) above, the Waterton Parking Borrower agrees that it, the members of Waterton Parking Borrower, and the members, partners or stockholders of any entity controlling, directly or indirectly, Waterton Parking Borrower, will not:
 - (a) sell, assign, transfer, hypothecate, grant a security interest in or convey title to (i) the Mortgaged Property or any part thereof, or (ii) any membership interest in Waterton Parking Borrower, or (iii) any membership interest, partnership interest or stock in any entity controlling, directly or indirectly, Waterton Parking Borrower; provided, however, that so long as any Individual Guarantor controls the management and operation of the Waterton Parking Borrower and maintains their current ownership (direct or indirect) interests in Waterton Parking Borrower, and so long as such transfer complies with applicable laws, including, without limitation, any "know your customer" review requirements, the following permitted transfers shall be permitted without Administrative Agent's prior written consent (collectively, "Permitted Transfers"): transfers of non-managing interests in Waterton Parking Borrower (direct or indirect) for estate planning purposes with prior, written notice to Administrative Agent, including transfer of interests or snares, as applicable, in Manager or Manager's Manager between David W. Ruttenberg and Alan D. Lev in the event of the death or declaration of legal incompetency of either of them:
 - (b) obtain any financing, all or a part of which, will be secured by (i) the Mortgaged Property, or (ii) any membership interest in Waterton Parking Borrower, or (iii) any membership interest, partnership interest or stock in any entity controlling, directly or indirectly, Waterton Parking Borrower; or
 - (c) convert the Waterton Parking Borrower from one type of legal entity into another type of legal entity,

without, in each instance, the Administrative Agent's prior written consent. Any violation of this Section 12 shall be deemed a "Prohibited Transfer."

- 13. Events of Default. Any one or more of the following event: shall constitute an "Event of Default" under this Mortgage:
 - (a) If the Waterton Parking Borrower shall fail (i) to make any payment of principal or interest under the Note within five (5) days of the date when due (except no grace period shall be permitted for payments due at maturity), or (ii) to make any other payment under the Loan Documents within five (5) days of the date when due or, if no date is stated five (5) days after demand (or such shorter period as may be expressly provided for herein or therein); or
 - (b) If the Waterton Parking Borrower shall fail to maintain the insurance coverages in effect as required in <u>Section 6</u> hereof; or
 - (c) If a Prohibited Transfer shall occur; or

- (d) If any representation or warranty made by Waterton Parking Borrower or any member thereof or any guarantor of the Note pursuant to or in connection with this Mortgage shall prove to be untrue or incorrect in any material respect; or
- Waterton Parking Borrower fails to perform or cause to be performed any other obligation or observe any other condition, covenant, term, agreement or provision required to be performed or observed by Waterton Parking Borrower contained in this Mortgage and not specifically referred to elsewhere in this Section 13; provided, however, that if such failure by its nature can be cured, then so long as the continued operation and safety of the Mortgaged Property, and the priority, validity and enforceability of the liens created by this Mortgage or any of the other Loan Documents and the value of the Mortgaged Property are not impaired, threatened or jeopardized, then Water on Parking Borrower shall have a period ("Cure Period") of thirty (30) days after Waterton Farking Borrower obtains actual knowledge of such failure or receives written notice of such failure to cure the same and an Event of Default shall not be deemed to exist during the Circ Period (provided, however, such period shall be limited to ten (10) days if such failure can be cured by the payment of money), provided further that if Waterton Parking Berrower commences to cure such failure during the Cure Period and is diligently and in good faith attempting to effect such cure, the Cure Period shall be extended for thirty (30) additional days, but in no event shall the Cure Period be longer than sixty (60) days in the aggregate; or
 - (f) If any Event of Default cours under any other Loan Document.
- 14. Remedies. Upon the occurrence of an Event of Default (regardless of the pendency of any proceeding which has or might have de effect of preventing Waterton Parking Borrower from complying with the terms of this instrument), and in addition to such other rights as may be available under any other Loan Document of under applicable law, but subject at all times to any mandatory legal requirements:
 - (a) Acceleration. Administrative Agent may declar: the outstanding principal balance of the Notes and all unpaid indebtedness of Waterton Parking Borrower hereby secured, including interest then accrued thereon, to be forthwith due and payable, whereupon the same shall become and be forthwith due and payable, with out other notice or demand of any kind.
 - (b) <u>Uniform Commercial Code</u>. Administrative Agent shall, with respect to the Personal Property, have all the rights, options and remedies of a secured party under the Code, including without limitation, the right to the possession of any such property or any part thereof, and the right to enter with legal process any premises where any such property may be found. Any requirement of said Code for reasonable notification shall be met by mailing written notice to Waterton Parking Borrower at its address set forth in <u>Section 31</u> hereof at least ten (10) days prior to the sale or other event for which such notice is required. Any such sale may be held as part of and in conjunction with any foreclosure sale of the other properties and rights constituting the Mortgaged Property in order that the Mortgaged Property, including the Personal Property, may be sold as a single parcel if the Administrative Agent elects. The Waterton Parking Borrower hereby

agrees that if the Administrative Agent demands or attempts to take possession of the Personal Property or any portion thereof in exercise of its rights and remedies hereunder, the Waterton Parking Borrower will promptly turn over and deliver possession thereof to the Administrative Agent, and the Waterton Parking Borrower authorizes, to the extent the Waterton Parking Borrower may now or hereafter lawfully grant such authority, the Administrative Agent, its employees and agents, and potential bidders or purchasers to enter upon the Mortgaged Property or any other office, building or property where the Personal Property or any portion thereof may at the time be located (or believed to be located) and the Administrative Agent may (i) remove the same therefrom or render the same inoperable (with or without removal from such location); (ii) repair, operate, use or manage the Personal Property or any portion thereof; (iii) maintain, repair or store the Personal Property or any portion thereof; (iv) view, inspect and prepare the Personal Property or any portion thereof for sale, lease or disposition; (v) sell, lease, dispose of or consume the same or bid thereon; or (vi) incorporate the Personal Property or any portion thereof into the Land or the Improvements or Fixtures and sell, convey or transfer the The expenses of retaking, selling and otherwise disposing of the Personal Property, including reasonable attorneys' fees and legal expenses incurred in connection therewith, shall consider so much additional Debt and shall be payable upon demand with interest at the Default Rate.

(c) Foreclosure. Administrative Agent may proceed to protect and enforce the rights of Administrative Agent hereunder (i) by any action at law, suit in equity or other appropriate proceedings, whether for the specific performance of any agreement contained herein, or for an injunction against the violation of any of the terms hereof, or in aid of the exercise of any power granted hereby or by law, or (ii) by the foreclosure of this Mortgage. In any suit to foreclose the Pen hereof, there shall be allowed and included as additional Debt in the decree of sale, all expenditures and expenses authorized by the Illinois Mortgage Foreclosure Law, 735 ILCS 5/15-1101 et. seq., as from time to time amended (the "Act") and all other expenditures and expenses which may be paid or incurred by or on behalf of Administrative Agent for reasonable attorney's fees, appraiser's fees, outlays for documentary and expert evidence, stenographer's charges, publication costs, and costs (which may be reasonably estimated as to items to be expended after entry of the decree) of procuring all such abstracts of title, title searches and examinations, title insurance policies, and similar data and assurance with respect to title as Administrative Agent may deem reasonably necessary either to prosecute such suit or to evidence to bidders at sales which may be not pursuant to such decree the true conditions of the title to or the value of the Mortgaged Property. All expenditures and expenses of the nature mentioned in this paragraph, and such other expenses and fees as may be incurred in the protection of the Mortgaged Property and rents and income therefrom and the maintenance of the lien of this Mortgage, including the reasonable fees of any attorney employed by Administrative Agent in any litigation or proceedings affecting this Mortgage, the Notes or the Mortgaged Property, including bankruptcy proceedings, or in preparation of the commencement or defense of any proceedings or threatened suit or proceeding, or otherwise in dealing specifically therewith, shall be so much additional Debt and shall be immediately due and payable by Waterton Parking Borrower, with interest thereon at the Default Rate until paid.

- Appointment of Receiver. Administrative Agent shall, as a matter of (d) right, without notice and without giving bond to Waterton Parking Borrower or anyone claiming by, under or through it, and without regard to the solvency or insolvency of Waterton Parking Borrower or the then value of the Mortgaged Property, be entitled to have a receiver appointed pursuant to the Act of all or any part of the Mortgaged Property and the rents, issues and profits thereof, with such power as the court making such appointment shall confer, and Waterton Parking Borrower hereby consents to the appointment of such receiver and shall not oppose any such appointment. Any such receiver may, to the extent permitted under Applicable Law, without notice, enter upon and take possession of the Mortgaged Property or any part thereof by summary proceedings, ejectment or otherwise, and may remove Waterton Parking Borrower or other rersons and any and all property therefrom, and may hold, operate and manage the same and receive all earnings, income, rents, issues and proceeds accruing with respect thereto or any part thereof, whether during the pendency of any foreclosure or until any right of rede at tion shall expire or otherwise.
- Administrative Agent, Waterton Parking Borrower shall surrender to Administrative Agent and Administrative Agent may enter and take possession of the Mortgaged Property or any part the eof personally, by its agent or attorneys or be placed in possession pursuant to court order as mortgagee in possession or receiver as provided in the Act, and Administrative Agent in its discretion, personally, by its agents or attorneys or pursuant to court order as mortgagee in possession or receiver as provided in the Act may enter upon and take and maintain possession of all or any part of the Mortgaged Property, together with all documents, books, records, papers, and accounts of Waterton Parking Borrower relating thereto, and may exclude Waterton Parking Borrower and any agents and servants thereof wholly therefrom and may, on behalf of Waterton Parking Borrower, or in its own name as Administrative Agent and under the powers herein granted:
 - (i) hold, operate, manage and control all or any part of the Mortgaged Property and conduct the business, if any, thereof, either personally or by its agents, with full power to use such measures, legal or equitable, as in its discretion may be deemed proper or necessary to enforce the payment or security of the rents, issues, deposits, profits, and avails of the Mortgaged Property, including without limitation actions for recovery of rent, actions in forcible detainer, and actions in distress for rent, all without notice to Waterton Parking Borrower;
 - (ii) cancel or terminate any lease or sublease of all or any part of the Mortgaged Property for any cause or on any ground that would entitle Waterton Parking Borrower to cancel the same:
 - (iii) elect to disaffirm any lease or sublease of all or any part of the Mortgaged Property made subsequent to this Mortgage without Administrative Agent's prior written consent;

- (iv) extend or modify any then existing leases and make new leases of all or any part of the Mortgaged Property, which extensions, modifications, and new leases may provide for terms to expire, or for options to lessees to extend or renew terms to expire, beyond the Maturity Date of the Loan and the issuance of a deed or deeds to a purchaser or purchasers at a foreclosure sale, it being understood and agreed that any such leases, and the options or other such provisions to be contained therein, shall be binding upon Waterton Parking Borrower, all persons whose interests in the Mortgaged Property are subject to the lien hereof, and the purchaser or purchasers at any foreclosure sale, notwithstanding any redemption from sale, discharge of the Debt, satisfaction of any foreclosure decree, or issuance of any certificate of sale or deed to any such purchaser;
- (v) make all necessary or proper repairs, renewals, replacements, afterzions, additions, betterments, and improvements in connection with the Mortgaged Property as may seem judicious to Administrative Agent, to insure and reinsure the Mortgaged Property and all risks incidental to Administrative Agent's possession, operation and management thereof, and to receive all rents, issues, deposits, profits, and avails therefrom;
- (vi) apply the net income, after allowing a reasonable fee for the collection thereof and fer the management of the Mortgaged Property, to the payment of taxes, premiums and other charges applicable to the Mortgaged Property, or in reduction of the Debt in such order and manner as Administrative Agent shall select, in its sole discretion; and
- (vii) receive and collect the rents, issues, profits and revenues of the Mortgaged Property personally or through a receiver so long as an Event of Default shall exist and during the pendency of any foreclosure proceedings and during any redemption period, and the Waterton Parking Borrower agrees to consent to a receiver if it is believed necessary or desircble by the Administrative Agent to enforce its rights under this sub. The collection of rents, issues, profits or revenues of the Mortgaged Property by the Administrative Agent shall in no way waive the right of the Administrative Agent to foreclose this Mortgage in the event of any said Event of Default.

Nothing herein contained shall be construed as constituting Administrative Agent a mortgagee in possession in the absence of the actual taking of possession of the Mortgaged Property. The right to enter and take possession of the Mortgaged Property and use any personal property therein, to manage, operate, conserve and improve the same, and to collect the rents, issues and profits thereof, shall be in addition to all other rights or remedies of Administrative Agent hereunder or afforded by law, and may be exercised concurrently therewith or independently thereof or under the other Loan Documents. The expenses (including any receiver's fees, reasonable counsel fees, costs and agent's compensation) incurred pursuant to the powers herein contained shall be secured hereby which expenses Waterton Parking Borrower promises to pay upon demand together with interest thereon at the Default Rate. Administrative Agent shall not be liable to account to Waterton Parking Borrower for any action taken pursuant hereto other

than to account for any rents actually received by Administrative Agent. Without taking possession of the Mortgaged Property, Administrative Agent may, in the event the Mortgaged Property become vacant or are abandoned, take such steps as it deems appropriate to protect and secure the Mortgaged Property (including hiring watchmen therefor) and all costs incurred in so doing shall constitute so much additional Debt payable upon demand with interest thereon at the Default Rate.

(f) Indemnity. The Waterton Parking Borrower hereby agrees to indemnify, defend, protect and hold harmless the Administrative Agent and its employees, officers and agents from and against any and all liabilities, claims and obligations which may be incurred, asserted or imposed upon them or any of them as a result of or in connection with any use, operation, or lease of any of the Mortgaged Property, or any part thereof, or as a result of the Administrative Agent seeking to obtain performance of any of the obligations due with respect to the Mortgaged Property; provided, however, that the foregoing indemnity shall not extend to such liabilities, claims or obligations as result from the gross regligence or intentional misconduct of the Administrative Agent, its employees, officers or agents.

15. Compliance with Illinois Mortgage Foreclosure Law.

- (a) In the event that any provision in this Mortgage shall be inconsistent with any provision of the Act, the provisions of the Act shall take precedence over the inconsistent provisions of this Mortgage, but shall not invalidate or render unenforceable any other provision of this Mortgage that can be construed in a manner consistent with the Act.
- (b) If any provision of this Mortgage small grant to Administrative Agent any rights or remedies upon the occurrence of an Event of Default which are more limited than the rights that would otherwise be vested in Administrative Agent under the Act in the absence of said provision, Administrative Agent shall be vested with the rights granted in the Act to the full extent permitted by law.
- (c) Without limiting the generality of the foregoing, all expenses incurred by Administrative Agent to the extent reimbursable under Sections 5/15-1510 and 5/15-1512 of the Act, whether incurred before or after any decree or judgment of foreclosure, and whether enumerated in Sections 14(c) or 17 of this Mortgage, shall be added to the Debt and shall be immediately due and payable by Waterton Parking Borrower, with interest thereon at the Default Rate until paid or shall be included in the judgment of foreclosure.
- Parking Borrower shall not and will not apply for or avail itself of any appraisement, valuation, stay, extension or exemption laws, or any so-called "Moratorium Laws," now existing or hereafter enacted in order to prevent or hinder the enforcement or foreclosure of this Mortgage, but hereby waives the benefit of such Moratorium Laws. Waterton Parking Borrower for itself and all who may claim through or under it waives any and all right to have the property and estates comprising the Mortgaged Property marshalled upon any foreclosure of the lien hereof and agrees that any court having jurisdiction to foreclose such lien may order the Mortgaged

Property sold as an entirety. In the event of any sale made under or by virtue of this instrument, the whole of the Mortgaged Property may be sold in one parcel as an entirety or in separate lots or parcels at the same or different times, all as the Administrative Agent may determine in its sole discretion. Administrative Agent shall have the right to become the purchaser at any sale made under or by virtue of this instrument and Administrative Agent so purchasing at any such sale shall have the right to be credited upon the amount of the bid made therefor by Administrative Agent with the amount payable to Administrative Agent out of the net proceeds of such sale. In the event of any such sale, the outstanding principal amount of the Loan and the other Debt, if not previously due, shall be and become immediately due and payable without demand or notice of any kind. Waterton Parking Borrower acknowledges that the Mortgaged Property does not constitute agricultural real estate, as defined in Section 5/15-1201 of the Act, or residential real estate, as defined in Section 5/15-1219 of the Act. To the fullest extent permitted by 12: Waterton Parking Borrower, on behalf of Waterton Parking Borrower, and each and every person acquiring any interest in, or title to the Mortgaged Property described herein subsequent to the date of this Mortgage, and on behalf of all other persons to the extent permitted by applicable law, hereby voluntarily and knowingly waives (i) any and all rights of redemption pursuant to Section 5/15-1601(b) of the Act, and (ii) any and all rights of reinstatement.

17. Costs and Expenses of Foreclosure. In any suit to foreclose the lien hereof there shall be allowed and included as additional indebtedness in the decree for sale all expenditures and expenses which may be paid or included by or on behalf of Administrative Agent for appraiser's fees, outlays for documentary and expert evidence, stenographic charges, publication costs and costs (which may be estimated as to items to be expended after the entry of the decree) of procuring all such abstracts of title, title searches and examination, guarantee policies, and similar data and assurances with respect to title as Administrative Agent may deem to be reasonably necessary either to prosecute any foreclosure action or to evidence to the bidder at any sale pursuant thereto the true condition of the title to or the value of the Mortgaged Property, and reasonable attorneys' fees, all of which expenditures shall become so much additional Debt which Waterton Parking Borrower agrees to pay and all of such expenditure until paid at the Default Rate.

18. Protective Advances.

- (a) Advances, disbursements and expenditures made by Administrative Agent for the following purposes, whether before and during a foreclosure, and at any time prior to sale, and, where applicable, after sale, and during the pendency of any related proceedings, for the following purposes, shall, in addition to those otherwise authorized by this Mortgage, constitute "Protective Advances":
 - (i) all advances by Administrative Agent in accordance with the terms of this Mortgage to: (A) preserve or maintain, repair, restore or rebuild the improvements upon the Mortgaged Property; (B) preserve the lien of this Mortgage or the priority thereof; or (C) enforce this Mortgage, as referred to in Subsection (b)(5) of Section 5/15-1302 of the Act;

- (ii) payments by Administrative Agent of: (A) when due, installments of principal, interest or other obligations in accordance with the terms of any prior lien or encumbrance; (B) when due, installments of real estate taxes and assessments, general and special and all other taxes and assessments of any kind or nature whatsoever which are assessed or imposed upon the mortgaged real estate or any part thereof; (C) other obligations authorized by this Mortgage; or (D) with court approval, any other amounts in connection with other liens, encumbrances or interests reasonably necessary to preserve the status of title to the Mortgaged Property, as referred to in Section 5/15-1505 of the Act;
- (iii) advances by Administrative Agent in settlement or compromise of any claims asserted by claimants under any prior liens;
- (iv) reasonable attorneys' fees and other costs incurred: (A) in commention with the foreclosure of this Mortgage as referred to in Section 5/15-1504(d)(2) and 5/15-1510 of the Act; (B) in connection with any action, suit or proceeding brought by or against the Administrative Agent for the enforcement of this Mortgage of arising from the interest of the Administrative Agent hereunder or under any of the other Loan Documents; or (C) in the preparation for the commencement or defense of any such foreclosure or other action;
- (v) Administrative Agent's fees and costs, including reasonable attorneys' fees, arising between the entry of judgment of foreclosure and the confirmation hearing as referred to in Subsection (b)(1) of Section 5/15-1508 of the Act;
- (vi) advances of any amount required to make up a deficiency in deposits for installments of taxes and assessments and insurance premiums as may be authorized by this Mortgage;
- (vii) expenses deductible from proceeds of sale as referred to in Subsections (a) and (b) of Section 5/15-1512 of the Act; and
- (viii) expenses incurred and expenditures made by Administrative Agent for any one or more of the following: (A) premiums for casually and liability insurance paid by Administrative Agent whether or not Administrative Agent or a receiver is in possession, if reasonably required, in reasonable amounts, and all renewals thereof, without regard to the limitation to maintaining of existing insurance in effect at the time any receiver or mortgagee takes possession of the mortgaged real estate imposed by Subsection (c)(1) of Section 5/15-1704 of the Act; (B) repair or restoration of damage or destruction in excess of available Insurance Proceeds or condemnation awards; (C) payments required or deemed by Administrative Agent to be for the benefit of the Mortgaged Property under any grant or declaration of easement, easement agreement, agreement with any adjoining land owners or instruments creating covenants or restrictions for the benefit of or affecting the Mortgaged Property; (D) shared or common expense assessments payable to any association or corporation in which the owner of the

mortgaged real estate is a member in any way affecting the Mortgaged Property; (E) pursuant to any lease or other agreement for occupancy of the mortgaged real estate.

- (b) All Protective Advances shall be so much additional Debt, and shall become immediately due and payable without notice and with interest thereon from the date of the advance until paid at the Default Rate.
- (c) This Mortgage shall be a lien for all Protective Advances as to subsequent purchasers and judgment creditors from the time this Mortgage is recorded pursuant to Subsection (b)(5) of Section 5/15-1302 of the Act.
- (d) All Protective Advances shall, except to the extent, if any, that any of the same is clearly contrary to or inconsistent with the provisions of the Act, apply to and be included in tre:
 - (i) determination of the amount of Debt at any time;
 - (ii) inaebtedness found due and owing to the Administrative Agent in the judgment of fo eclosure and any subsequent supplemental judgments, orders, adjudications or finding; by the court of any additional indebtedness becoming due after such entry of judgment, it being agreed that in any foreclosure judgment, the court may reserve jurisdiction for such purpose;
 - (iii) determination of a neunts deductible from sale proceeds pursuant to Section 5/15-1512 of the Act:
 - (iv) application of income in the hands of any receiver or mortgagee in possession; and
 - (v) computation of any deficiency judgment pursuant to Subsections (b)(2) and (e) of Section 5/15-1508 and Section 5/15-1511 of the Act.
- 19. Application of Proceeds. The proceeds of any foreclosure sale of the Mortgaged Property or of any sale of property pursuant to Section 14(c) hereof shall be distributed in the following order of priority: First, on account of all costs and expenses incident to the foreclosure or other proceedings including all such items as are mentioned in Section 14(c) and Section 17 hereof; second, to all items, other than principal and interest evidenced by the Notes, which under the terms hereof constitute Debt with interest thereon as herein provided; third, to all unpaid interest on the Notes; fourth, to all unpaid principal on the Notes; fifth, to whomsoever shall be lawfully entitled to the same.

20. Rights Cumulative.

(a) Each right, power and remedy herein conferred upon the Administrative Agent is cumulative and in addition to every other right, power or remedy, express or implied, now or hereafter provided by law or in equity, and each and every right, power, and remedy herein set forth or otherwise so existing may be exercised from time to time

concurrently or independently and as often and in such order as may be deemed expedient by the Administrative Agent.

- (b) By accepting payment of any sums secured by this Mortgage after the due date thereof, by accepting performance of any of the Waterton Parking Borrower's obligations hereunder after such performance is due, or by making any payment or performing any act on behalf of the Waterton Parking Borrower which the Waterton Parking Borrower was obligated but failed to perform or pay, the Administrative Agent shall not waive, nor be deemed to have waived, its rights to require payment when due of all sums secured hereby and the due, punctual and complete performance of the Waterton Parking Borrower's obligations under this Mortgage, the Notes, and all other Loan Decuments. No waiver or modification of any of the terms of this Mortgage shall be binding on the Administrative Agent unless set forth in writing signed by the Administrative Agent and any such waiver by the Administrative Agent of any Event of Default by the Waterton Parking Borrower under this Mortgage shall not constitute a waiver of any other Event of Default under the same or any other provision hereof. If the Administrative Agent holds any additional security for any of the obligations secured hereby, it may pursue its rights or remedies with respect to such security at its option either before, contemporancously with, or after a sale of the Mortgaged Property or any portion thereof.
- No act or omission by the Administrative Agent shall release, discharge, (c) modify, change or otherwise affect the hability of Waterton Parking Borrower under the Notes, this Mortgage, or any of the other Loan Documents, or any other obligation of the Waterton Parking Borrower, or any subsequent purchaser of the Mortgaged Property or any part thereof, or any maker, co-signer, endorser, surety or guarantor, or preclude the Administrative Agent from exercising any right, power or privilege herein granted or intended to be granted in the event of any Event of Default then made or of any subsequent Event of Default, or alter the security interest or lien of this Mortgage or any of the other Loan Documents except as expressly provided in an instrument or instruments executed by the Administrative Agent. The exercise of one right, power or remedy shall not be a waiver of the right to exercise at the same time or thereafter any other right, power or remedy; and no delay or omission of the Administrative Agent in the exercise of any right, power or remedy accruing hereunder or under any of the other Loan Documents or arising otherwise shall impair any such right, power or rariedy, or be construed to be a waiver of any Event of Default or acquiescence therein. Except as otherwise specifically required herein, notice of the exercise of any right, remedy or power granted to the Administrative Agent by this Mortgage is not required to be given.

21. Successors and Assigns; Assignment.

(a) This Mortgage and each and every provision hereof shall be binding upon the Waterton Parking Borrower and its successors and assigns (including, without limitation, each and every record owner from time to time of the Mortgaged Property or any other person having an interest therein), and shall inure to the benefit of the Administrative Agent and its successors and assigns.

- (b) All of the covenants of this Mortgage shall run with the Land and be binding on any successor owners of the Land. In the event that the ownership of the Mortgaged Property or any portion thereof becomes vested in a person or persons other than the Waterton Parking Borrower, the Administrative Agent may, without notice to the Waterton Parking Borrower with such successor or successors in interest of the Waterton Parking Borrower with reference to this Mortgage and the Debt in the same manner as with the Waterton Parking Borrower without in any way releasing or discharging the Waterton Parking Borrower from its obligations hereunder. The Waterton Parking Borrower will give immediate written notice to the Administrative Agent of any conveyance, transfer or change of ownership of the Mortgaged Property, but nothing in this Section shall vary or negate the provisions of Section 12 hereof.
- Mortgage may not be assigned and any purported assignment by Waterton Parking Borrower singly be null and void. Administrative Agent shall have the right to sell, assign or transfer portions of its right, title and/or interest in and to this Mortgage and the other Loan Documents (including the sale of participation interests therein), without the consent or approval of Waterton Parking Borrower, and Waterton Parking Borrower agrees to cooperate in all respects with Administrative Agent in connection therewith, including, without limitation, the execution of all documents and instruments reasonably requested by Administrative Agent or such transferee provided that such documents and instruments do not materially adversely affect any of Waterton Parking Borrower's duties or obligations under this Mortgage and the other Loan Documents.

22. <u>Execution of Separate Security Agreements, Financing Statements, Etc.; Estoppel Letter; Corrective Documents.</u>

- (a) The Waterton Parking Borrower will do, execute, acknowledge and deliver or cause to be done, executed, acknowledged and delivered all such further acts, conveyances, notes, mortgages, security agreements, finar citig statements and assurances as the Administrative Agent shall reasonably require for the Letter assuring, conveying, mortgaging, assigning and confirming unto the Administrative Agent all property mortgaged hereby or property intended so to be, whether now owned by the Waterton Parking Borrower or hereafter acquired. Without limitation of the foregoing, the Waterton Parking Borrower will assign to the Administrative Agent, upon request, as further security for the Debt, its interest in all agreements, contracts, licenses and permits affecting the Mortgaged Property, such assignments to be made by instruments reasonably satisfactory to the Administrative Agent, but no such assignment shall be construed as a consent by the Administrative Agent to any agreement, contract, license or permit or to impose upon the Administrative Agent any obligations with respect thereto.
- (b) From time to time, the Waterton Parking Borrower will furnish, within ten (10) days after request from the Administrative Agent, a written and duly acknowledged statement of the amount due under the Notes and this Mortgage and whether any alleged offsets or defenses exist against the Debt.

- (c) The Waterton Parking Borrower and the Administrative Agent shall, at the request of the other, promptly correct any defect, error or omission which may be discovered in the contents of this Mortgage or in the execution or acknowledgment hereof or in any other instrument executed in connection herewith or in the execution or acknowledgment of such instrument and will execute and deliver any and all additional instruments as may be requested by the Administrative Agent or the Waterton Parking Borrower, as the case may be, to correct such defect, error or omission.
- 23. <u>Subrogation</u>. If any part of the Debt is used directly or indirectly to pay off, discharge or satisfy, in whole or in part, any prior lien or encumbrance upon the Mortgaged Property or any part thereof, then by advancing the monies to make such payment, the Administrative Agent shall be subrogated to the rights of the holder thereof in and to such other lien or encumorance and any additional security held by such holder, and shall have the benefit of the priority of the same.
- 24. Governing Law. The validity, enforcement and interpretation of this Mortgage shall for all purposes be governed by and construed in accordance with the laws of the State of Illinois, without reference to the conflicts of law principles of that State, and applicable United States federal law, and is intended to be performed in accordance with, and only to the extent permitted by, such laws.

25. Business Loan.

- (a) The Waterton Parking Borrower declares, represents, certifies and agrees that the proceeds of the Notes will be used solely for business purposes and that the loan is exempt from interest limitations pursuant to the provisions of 815 ILCS 205/4 and is an exempted transaction under the Truth in Lending Act, 15 U.S.C. Section 1601 et seq.
- (b) All rights, remedies and powers provided by this Mortgage may be exercised only to the extent that the exercise thereof does not violate any applicable provisions of law, and all the provisions of this Mortgage are intended to be subject to all applicable mandatory provisions of law which may be controlling and to be limited to the extent necessary so that they will not render this Mortgage invalid or unenforceable under the provisions of any applicable law.
- 26. Escrow Deposits. Upon Administrative Agent's request, and without limiting the effect of Sections 4, 5, and 6 hereof, the Administrative Agent may require that the Waterton Parking Borrower pay to the Administrative Agent on the first business day of each calendar month an amount equal to one-twelfth (1/12th) of what the Administrative Agent estimates is necessary to pay, on an annualized basis, (1) all Taxes, and (2) all premiums for the insurance policies required under Section 6 hereof ("Premiums") and to enable the Administrative Agent to pay same at least thirty (30) days before the Taxes would become delinquent and the Premiums are due, and, on demand, from time to time shall pay to the Administrative Agent additional sums necessary to pay the Premiums and Taxes. No amounts so paid shall be deemed to be trust funds, but may be commingled with the general funds of the Administrative Agent, and no interest shall be payable thereon. In the event that the Waterton Parking Borrower does not pay such sums for Premiums and Taxes, then the Administrative Agent may, but shall not be

obligated to, pay such Premiums and Taxes and any money so paid by the Administrative Agent shall constitute additional Debt hereunder and shall be payable by Waterton Parking Borrower to Administrative Agent on demand with interest thereon from the date of disbursement by Administrative Agent at Default Rate until repaid to Administrative Agent. If an Event of Default occurs, the Administrative Agent shall have the right, at its election, to apply any amounts so held under this Section 26 against all or any part of the Debt, or in payment of the Premiums or Taxes for which the amounts were deposited. The Waterton Parking Borrower will furnish to the Administrative Agent bills for Taxes and Premiums not less than thirty (30) days before Taxes become delinquent and such Premiums become due.

- Assignment of Leases and Other Agreements Affecting the Mortgaged Property. In order to the her secure payment of the Debt and the observance, performance and discharge of the Waterton Parking Borrower's obligations under the Loan Documents, the Waterton Parking Borrower hereby assigns to the Administrative Agent all of the Waterton Parking Borrower's right, title, interest and estate in, to and under all of the Leases and sales contracts now or hereafter affecting the Mortgaged Property or any part thereof (the "Sales Contracts") and in and to all of the Rents and Profits (defined as all rents, income, issues and profits arising from any Leases, Sales Contracts or other agreements affecting the use, enjoyment or occupancy of the Mortgaged Property now or hereafter made affecting the Mortgaged Property or any portion thereof), as more particularly described in that certain Assignment of Leases and Rents dated as of even herewith from Waterton Parking Borrower to and for the benefit of Administrative Agent. Unless and until an Event of Default occurs, the Waterton Parking Borrower shall be entitled to collect the Rents and Profits (except as otherwise provided in this Mortgage) as and when they become due and payable. Neither these assignments nor Administrative Agent's enforcement of the provisions of these assignments (including the receipt of the Rents) will operate to subordinate the lien of this Mortgage to any of the rights of any tenant or contract purchaser of all or any part of the Mortgaged Property, or to subject Administrative Agent to any liability to any such tenant or contract purchaser for the performance of any obligations of Waterton Parking Borrower under any such Lease or Sales Contract unless and until Administrative Agent agrees to such subordination or assumes such liability by an appropriate written instrument.
- 28. Inspection of Mortgaged Property and Records. The Administrative Agent and its representatives and agents shall have the right to inspect the Mortgaged Property and all books, records and documents relating thereto at all reasonable times, after giving reasonable notice to the Waterton Parking Borrower, and access thereto, subject to the rights of tenants pursuant to Leases. The Administrative Agent shall use reasonable efforts to avoid disturbing business operations on the Mortgaged Property during such inspections. The Waterton Parking Borrower or the Administrative Agent thereof shall keep and maintain full and correct books and records showing in detail the income and expenses of the Mortgaged Property and permit the Administrative Agent or its agents to examine such books and records and all supporting vouchers and data at any time and from time to time on request at its offices at the address hereinafter identified or at such other location as may be mutually agreed upon.
- 29. <u>Financial Statements</u>. The Waterton Parking Borrower represents and warrants that the financial statements for the Waterton Parking Borrower and the Mortgaged Property previously submitted to the Administrative Agent are true, complete and correct in all material

respects, disclose all actual and contingent liabilities of the Waterton Parking Borrower or relating to the Mortgaged Property and do not contain any untrue statement of a material fact or omit to state a fact material to such financial statements. No material adverse change has occurred in the financial condition of the Waterton Parking Borrower or the Mortgaged Property from the dates of said financial statements until the date hereof. The Waterton Parking Borrower shall furnish to the Administrative Agent such financial information regarding the Waterton Parking Borrower, its constituent partners or members, as the case may be, the Mortgaged Property and any guarantor of the Loan as the Administrative Agent may from time to time reasonably request, which shall include, without any further request therefor, the financial statements required pursuant to the Loan Agreement.

- 30 <u>Environmental Matters</u>. Concurrently herewith, Waterton Parking Borrower, Wabash Condominium Borrower and Guarantors shall execute and deliver an Environmental Indemnity Agreement in form satisfactory to Administrative Agent (the "<u>Environmental Indemnity Agreement</u>"). The performance of the covenants, undertakings and obligations of the indemnitors under the Environmental Indemnity Agreement shall be secured by this Mortgage.
- Notices. All nonces or other written communications hereunder shall be deemed to have been properly given (i) upon delivery, if delivered in person, (ii) one (1) business day after having been deposited for overnight delivery with any reputable overnight courier service, or (iii) three (3) business days after having been deposited in any post office or mail depository regularly maintained by the U.S. Postal Service and sent by registered or certified mail, postage prepaid, return receipt requested, addressed to the addresses set forth below in this Section or as such party may from time to time designate by written notice to the other parties. Either party by notice to the other in the manner provided herein may designate additional or different addresses for subsequent notices or communications:

32. Releases.

- (a) Upon payment in full of all sums due under the Notes, this Mortgage and the other of the Loan Documents, Administrative Agent shall, upon the request of and at the cost of the Waterton Parking Borrower, execute a proper release of this Mortgage. In addition Administrative Agent shall execute and deliver to mortgagee partial releases of this Mortgage upon the terms and conditions set forth in the Loan Agreement.
- (b) The Administrative Agent may, regardless of consideration, cause the release of any part of the Mortgaged Property from the lien of this Mortgage without in any manner affecting or impairing the lien or priority of this Mortgage as to the remainder of the Mortgaged Property not so released.
- 33. Indemnification by the Waterton Parking Borrower. partners, stockholders, directors, officers, agents or employees of the Administrative Agent by reason of any such occurrence, the Waterton Parking Borrower, upon the request of the Administrative Agent and at Waterton Parking Borrower's sole expense, shall resist and defend such action, suit or proceeding or cause the same to be resisted and defended by counsel designated by Waterton Parking Borrower and approved by the Administrative Agent. Such obligations under this paragraph shall survive the termination, satisfaction or release of this Mortgage.

34. OFAC Covenant. Waterton Parking Borrower shall ensure, and cause each of its subsidiaries to ensure, that (i) no person who owns twenty percent (20.00%) or more of the equity interests in the Waterton Parking Borrower, or otherwise controls the Waterton Parking Borrower of any of its subsidiaries is or shall be listed on the Specially Designated Nationals and Blocked Person. List or other similar lists maintained by the OFAC, the Department of the Treasury or included in any Executive Orders, (ii) the proceeds of the Loan do not violate any of the foreign asset control regulations of OFAC or any enabling statute or Executive Order relating thereto, and (iii) it shall comply, and cause each of its subsidiaries to comply, with all applicable Bank Secrecy Act ("BSA") laws and regulations, as amended.

35. Miscellaneous.

- (a) <u>Time is of the Essence</u>. Time is of the essence of this Mortgage.
- (b) <u>Captions and Pronouns</u>. The captions and headings of the various Sections of this Mortgage are for convenience only, and are not to be construed as confining or limiting in any way the scope or intent of the provisions hereof. Whenever the context requires or permits, the singular shall include the plural, the plural shall include the singular, and the masculine, feminine and neuter shall be freely interchangeable.
- (c) <u>Maximum Indebtedness</u>. Notwithstanding, anything contained herein to the contrary, in no event shall the Debt exceed an amount equal to \$121,700,000.00; provided, however, in no event shall the Lenders be obligated to advance funds in excess of the face amount of the Notes.
- (d) The Waterton Parking Borrower Not a Joint Venturer c: Partner. The Waterton Parking Borrower and the Administrative Agent acknowledge and agree that in no event shall the Administrative Agent be deemed to be a partner or joint venturer with the Waterton Parking Borrower. Without limitation of the foregoing, the Administrative Agent shall not be deemed to be such a partner or joint venturer on account of its becoming a mortgagee in possession or exercising any rights pursuant to this Mortgage or pursuant to any other instrument or document evidencing or securing any of the Debt, or otherwise.
- (e) Replacement of the Notes. Upon notice to the Waterton Parking Borrower of the loss, theft, destruction or mutilation of the Notes, the Waterton Parking Borrower will execute and deliver, in lieu thereof, a replacement note, identical in form and substance to the Notes and dated as of the date of the Note and upon such execution and

delivery all references in any of the Loan Documents to the Notes shall be deemed to refer to such replacement note.

- (f) <u>Waiver of Consequential Damages</u>. The Waterton Parking Borrower covenants and agrees that in no event shall the Administrative Agent be liable for consequential damages, whatever the nature of a failure by the Administrative Agent to perform its obligation(s), if any, under the Loan Documents, and the Waterton Parking Borrower hereby expressly waives all claims that it now or may hereafter have against the Administrative Agent for such consequential damages.
- (g) After Acquired Mortgaged Property. The lien hereof will automatically attach, without further act, to all after-acquired Mortgaged Property attached to and/or used in connection with or in the operation of the Mortgaged Property or any part thereof.
- (h) <u>Severability</u>. If any provision hereof should be held unenforceable or void, then such provision shall be deemed separable from the remaining provisions and shall in no way affect the validity of this Mortgage except that if such provision relates to the payment of any monetary sum, then the Administrative Agent may, at its option declare the Debt immediately due and payable.
- (i) Interpretation of Agreement. Should any provision of this Mortgage require interpretation or construction in any judicial, administrative, or other proceeding or circumstance, it is agreed that the parties hereto intend that the court, administrative body, or other entity interpreting or construing the same shall not apply a presumption that the provisions hereof shall be more strictly construed against one party by reason of the rule of construction that a document is to be construed more strictly against the party who itself or through its agent prepared the same, it being agreed that the agents of both parties hereto have fully participated in the preparation of all provisions of this Mortgage, including, without limitation, all Exhibits attached to this Mortgage.
- (j) Joint and Several Obligations; Counterparts. If this Mortgage is executed by more than one Borrower, (i) the obligations and liabilities of Waterton Parking Borrower under this Mortgage shall be joint and several and shall be binding upon and enforceable against each Borrower and their respective successors and assigns, and (ii) this Mortgage may be executed in counterparts, and all said counterparts when taken together shall constitute one and the same Mortgage.
- (k) Effect of Extensions and Amendments. If the payment of the Debt, or any part thereof, be extended or varied, or if any part of the security or guaranties therefor be released, all persons now or at any time hereafter liable therefor, or interested in the Mortgaged Property shall be held to assent to such extension, variation or release, and their liability, and the lien, and all provisions hereof, shall continue in full force and effect; the right of recourse against all such persons being expressly reserved by the Administrative Agent, notwithstanding any such extension, variation or release.
- (l) Mortgagee-in-Possession. Nothing herein contained shall be construed as constituting the Administrative Agent a mortgagee-in-possession in the absence of the

actual taking of possession of the Mortgaged Property by the Administrative Agent pursuant to this Mortgage.

- (m) No Merger. The parties hereto intend that the Mortgage and the lien hereof shall not merge in fee simple title to the Mortgaged Property, and if the Administrative Agent acquires any additional or other interest in or to the Mortgaged Property or the ownership thereof, then, unless a contrary intent is manifested by the Administrative Agent as evidenced by an express statement to that effect in an appropriate document duly recorded, this Mortgage and the lien hereof shall not merge in the fee simple title and this Mortgage may be foreclosed as if owned by a stranger to the fee simple title.
- Complete Agreement. This Mortgage, the Notes and the other Loan Documents constitute the complete agreement between the parties with respect to the subject matter hereof and the Loan Documents may not be modified, altered or amended except by an agreement in writing signed by both the Waterton Parking Borrower and the Administrative Agent.
- JURISDICTION AND VENUE. 36. WATERTON PARKING BORROWER HEREBY AGREES THAT ALL ACTIONS OR PROCEEDINGS INITIATED BY WATERTON PARKING BORROWER, AND ARISING DIRECTLY OR INDIRECTLY OUT OF THIS MORTGAGE SHALL BE LITIGATED IN THE CIRCUIT COURT OF COOK COUNTY, ILLINOIS, OR THE UNITED STATES DISTRICT COURT FOR THE NORTHERN DISTRICT OF ILLINOIS OR IF ADMINISTRATIVE AGENT INITIATES SUCH ACTION, ANY COURT IN WHICH ADMINISTRATIVE AGENT SHALL INITIATE SUCH ACTION AND WHICH HAS JURISDICTION. WATERTON PARKING BORROWER HEREBY EXPRESSLY SUBMITS AND CONSENTS IN ADVANCE TO SUCH JURISDICTION IN ANY ACTION OR PROCFEDING COMMENCED ADMINISTRATIVE AGENT IN ANY OF SUCH COURTS, AND HEREBY WAIVES PERSONAL SERVICE OF THE SUMMONS AND COMPLAIN R OR OTHER PROCESS OR PAPERS ISSUED THEREIN, AND AGREES THAT SERVICE OF SUCH SUMMONS AND COMPLAINT OR OTHER PROCESS OR PAPERS MAY BE MADE BY REGISTERED OR CERTIFIED MAIL ADDRESSED TO WATERTON PARKING BORKOWER AT THE ADDRESS TO WHICH NOTICES ARE TO BE SENT PURSUANT TO THIS MORTGAGE. WATERTON PARKING BORROWER WAIVES ANY CLAIM THAT CHICAGO, ILLINOIS OR THE NORTHERN DISTRICT OF ILLINOIS IS AN INCONVENIENT FORULA OR AN IMPROPER FORUM BASED ON LACK OF VENUE. SHOULD WATERTON PARKING BORROWER, AFTER BEING SO SERVED, FAIL TO APPEAR OR ANSWER TO ANY SUMMONS, COMPLAINT, PROCESS OR PAPERS SO SERVED WITHIN THE NUMBER OF DAYS PRESCRIBED BY LAW AFTER THE MAILING THEREOF, WATERTON PARKING BORROWER SHALL BE DEEMED IN DEFAULT AND AN ORDER AND/OR JUDGMENT MAY BE ENTERED BY ADMINISTRATIVE AGENT AGAINST WATERTON PARKING BORROWER AS DEMANDED OR PRAYED FOR IN SUCH SUMMONS, COMPLAINT, PROCESS OR PAPERS. THE EXCLUSIVE CHOICE OF FORUM FOR WATERTON PARKING BORROWER SET FORTH IN THIS MORTGAGE SHALL NOT BE DEEMED TO PRECLUDE THE ENFORCEMENT BY ADMINISTRATIVE AGENT OF ANY JUDGMENT OBTAINED IN ANY OTHER FORUM OR THE TAKING BY

ADMINISTRATIVE AGENT OF ANY ACTION TO ENFORCE THE SAME IN ANY OTHER APPROPRIATE JURISDICTION, AND WATERTON PARKING BORROWER HEREBY WAIVES THE RIGHT, IF ANY, TO COLLATERALLY ATTACK ANY SUCH JUDGMENT OR ACTION.

- ADMINISTRATIVE AGENT HEREBY VOLUNTARILY, KNOWINGLY, IRREVOCABLY AND UNCONDITIONALLY WAIVE ANY RIGHT TO HAVE A JURY PARTICIPATE IN RESOLVING ANY DISPUTE (WHETHER BASED UPON CONTRACT, TORT OR OTHERWISE) BETWEEN OR AMONG WATERTON PARKING BORROWER AND ADMINISTRATIVE AGENT ARISING OUT OF OR IN ANY WAY RELATED TO THIS MORTGAJE, ANY OTHER LOAN DOCUMENT, OR ANY RELATIONSHIP BETWEEN WATERTON PARKING BORROWER AND ADMINISTRATIVE AGENT. THIS PROVISION IS A MATERIAL INDUCEMENT TO LENDERS TO PROVIDE THE LOAN DESCRIBED HEREIN AND IN THE OTHER LOAN DOCUMENTS.
- 38. Additional Waivers. WATERTON PARKING BORROWER EXPRESSLY AND UNCONDITIONALLY WAIVES, IN CONNECTION WITH ANY SUIT, ACTION OR PROCEEDING BROUGHT BY ADMINISTRATIVE AGENT ON THIS MORTGAGE, ANY AND EVERY RIGHT IT MAY HAVE TO (A) INTERPOSE ANY COUNTERCLAIM THEREIN UNLESS UNDER THE APPLICABLE RULES OF COURT SUCH COUNTERCLAIM MUST BE ASSERTED IN SUCH PROCEEDING, OR (B) HAVE THE SAME CONSOLIDATED WITH ANY OTHER OR SEPARATE SUIT, ACTION OR PROCEEDING UNLESS UNDER THE APPLICABLE RULES OF COURT SUCH SUIT, ACTION OR PROCEEDING MUST BE CONSOLIDATED WITH THE PROCEEDING BROUGHT BY ADMINISTRATIVE AGENT.
- 39. Compliance with Loan Agreement. Waterton Parking Borrower will abide by and comply with and be governed and restricted by all of the terms, covenants, provisions, restrictions and agreements contained in the Loan Agreement, and in each and every supplement thereto or amendment thereof which may at any time or from time to time be executed and delivered by the parties thereto or their successors and assigns.
- 40. Provisions of Loan Agreement. The proceeds of the Notes are to be disbursed by the Administrative Agent in accordance with the terms contained in the Loan Agreement, the provisions of which are incorporated herein by reference to the same extent as if fully set forth herein. Waterton Parking Borrower covenants that any and all monetary disbursements made in accordance with the Loan Agreement shall constitute adequate consideration to Waterton Parking Borrower for the enforceability of this Mortgage and the Notes, and that all advances and indebtedness arising and accruing under the Loan Agreement from time to time, whether or not the total amount thereof may exceed the face amount of the Notes, shall be secured by this Mortgage; provided, however, that the total Debt shall not in any event exceed two hundred percent of the stated principal amount of the Notes.
- 41. <u>Construction Loan</u>. The Notes evidence a debt created by one or more disbursements made by Administrative Agent to Waterton Parking Borrower to finance the cost of the construction of certain improvements upon the Land in accordance with the provisions of

the Loan Agreement, and this Mortgage is a construction mortgage as such term is defined in Section 9-334(h) of the Code.

42. Remedies Against Other Collateral. The Waterton Parking Borrower acknowledges that this Mortgage, the Waterton Parking Mortgage and the other Loan Documents are cross-defaulted and the Loan secured hereby is also secured by the other Loan Documents. The Waterton Parking Borrower agrees that the Lender may proceed, at the same or at different times, to foreclose any or all liens against such collateral (or sell such collateral under power of sale) by any proceedings appropriate in the county and state where such collateral lies, and that no event of enforcement taking place in any county or state pursuant to any of the Loan Documents shall preclude or bar enforcement in any other county or state. Any foreclosure or other appropriate remedy brought in any county or state in which collateral is located may be brought and prosecuted as to any part of such collateral without regard to the fact that foreclosure proceedings or other appropriate remedies have or have not been instituted elsewhere on any other part of the collateral for the Loan.

EXHIBIT B

INSURANCE REQUIREMENTS

- 1. <u>Property Insurance</u>. For so long as any of the Debt is outstanding, Waterton Parking Borrower shall continuously maintain property insurance in accordance with the following provisions:
 - Special Perils Form/All Risk Property Coverage. Waterton Parking Borrower (a) shall maintain property insurance with respect to the Improvements, Fixtures and Personal Property insuring against any peril now or hereafter included within the classification "All Risks of Physical Loss," including, without limitation, losses from fire, lightning, building collapse, debris removal, windstorm, hail, explosion, smoke, aircraft and vehicle damage, riot, vandalism and malicious mischief, falling objects, impact of vehicles and aircraft, weight of snow, ice or sleet, collapse, mudslide, sinkhole, subsidence, tsuna ni, water damage and sprinkler leakage, in amounts at all times sufficient to prevent Waterton Parking Borrower or Administrative Agent from becoming a co-insurer within the terms of the applicable law, but in any event such insurance shall be maintained in an amount equal to the full replacement cost of the Improvements, The term "replacement cost" means the actual Fixtures and Personal Property. replacement cost (without taling into account any depreciation and exclusive of excavations, footings and foundation, landscaping and paving) determined annually by an insurer, a recognized independent insurance agent or broker or an independent appraiser selected and paid by Waterton Parking Borrower. The policy shall include an agreed amount endorsement or a waiver of the course requirement and an inflation guard endorsement.

(b) Intentionally Omitted.

(c) <u>Boiler and Machinery Coverage</u>. Waterton Parking Borrower shall maintain broad form, replacement cost basis boiler and machinery insurance (without exclusion for explosion) covering all boilers or other pressure vessels, machinery, equipment and air conditioning or heating units located in, on or about the Mortgaged Property and insurance against physical loss, rental loss, extra expense, expediting loss and loss of occupancy or use arising from any breakdown in such amounts as are generally required by institutional lenders for properties comparable to the Mortgaged Property.

(d) Intentionally Omitted.

- (e) <u>Building Ordinance or Law</u>. Waterton Parking Borrower shall maintain building ordinance coverage in amount of at least 25% of the building coverage limit.
- (f) <u>Builder's Risk</u>. Waterton Parking Borrower shall maintain at all times during which structural construction, repair or alterations are being made with respect to the Mortgaged Property (1) owner's contingent or protective liability insurance covering claims not covered by or under the terms or provisions of the commercial general liability insurance policy, and (2) the insurance provided for in subsection (a) above written on a

builder's risk completed value form (a) on a non-reporting basis, (b) against all risks of physical loss, including earthquake and flood, (c) including permission to occupy the subject property, and (d) with an agreed amount endorsement (including soft costs), specifications, blueprints/models, demolition, increased cost of construction and rental interruption for delayed opening as pertinent, waiving co-insurance provisions.

- (g) Terrorism Coverage. Upon Administrative Agent's request, in the event that such coverage with respect to terrorist acts is not included as part of the insurance policy required by subsection (a) above, coverage against loss or damage by terrorist acts in an amount equal to one hundred percent (100%) of the full replacement value of the Improvements, Fixtures and Personal Property, with a co-insurance clause, if any, only as acceptable to Administrative Agent.
- 2. <u>Ciability Insurance</u>. For so long as any of the Debt is outstanding, Waterton Parking Borrower chall continuously maintain liability insurance in accordance with the following provisions:
 - (a) Commercial General Liability Insurance. Waterton Parking Borrower shall maintain commercial general liability insurance, including bodily injury and property damage liability insurance against any and all claims, including all legal liability to the extent insurable and imposed upon Administrative Agent and all court costs and attorneys' fees and expenses, arising out of or connected with the possession, use, leasing, operation, maintenance or condition of the subject property in amounts not less than \$1,000,000 per occurrence per year and an excess/umbrella liability coverage in an amount not less than \$5,000,000. Such hability insurance must be occurrence-based coverage, rather than claims made coverage. This insurance must stand on its own with no shared participation or proration and be on a following form basis.
 - (b) Intentionally Omitted.
 - (c) <u>Automobile</u>. Waterton Parking Borrower shall maritain automobile liability insurance if over the road vehicles, whether owned, hired or non-owned, are operated in conjunction with the Mortgaged Property. The combination of the primary automobile liability and applicable umbrella/excess liability must equal a minimum of Five Million Dollars (\$5,000,000) combined single limit.
 - (d) <u>Workers' Compensation and Employer's Liability Insurance</u>. Water on Parking Borrower shall maintain workers' compensation and employers' liability insurance with respect to any work on or about the Mortgaged Property for the contractor and all subcontractors. Liability limits shall be a minimum of:
 - (i) Workers Compensation Statutory as required by state law
 - (ii) Employers' Liability –

Bodily injury by accident
Bodily injury by disease
Bodily injury by disease
S1,000,000 each accident
\$1,000,000 each employee
\$1,000,000 policy limit

3. Additional Insurance. Waterton Parking Borrower shall maintain such other insurance with respect to Waterton Parking Borrower and the subject property against loss of damage of the kinds from time to time required by Administrative Agent. Without limitation to the foregoing, Waterton Parking Borrower shall cause each Contractor to maintain General Liability insurance, including without limitation, products and completed operations and auto liability insurance, with limits of no less than \$5,000,000 per occurrence and in the aggregate through primary and umbrella liability policies. Waterton Parking Borrower shall also ensure that all subcontractors maintain similar coverage with limits appropriate to the hazard associated with their respective work on the Project. All parties engaged in work on the Project shall or Cook County Clerk's Office maintain statutory Workers Compensation and employers liability insurance with limits of at least \$1,000,000.
