If substantially equivalent Mortgage Insurance coverage is not available, Borrower shall continue to pay to Lender the amount of the separately designated payments that were due when the insurance coverage ceased ( be in effect. Lender will accept, use and retain these payments as a non-refundable loss reserve in lieu of Mortgage linar nee. 
