This cause coming to be heard on the Motion of EQUITY ONE INVESTMENT FUND, LLC to Declare Order Directing Issuance of Tax Deed and Tax Deed Void and for a Refund Pursuant to 35 ILCS 200/22-80(A), this Court having jurisdiction over the parties and subject matter and based upon testimony elicited and the evidence offered and admitted,

IT IS HEREBY ORDERED ADJUDGED AND DECREED:

1. That EQUITY ONE INVESTMENT FUND, LLC'S Motion to Declare Order Directing the Issuance of Tax and Tax Deed Void and for a Refund Pursuant to 35 ILCS 200/22-80(A) is granted
2. That the Order Directing the Issuance of Tax Deed entered on July 18, 2017 is declared void.
3. That Tax Deed Number 37159, recorded with the Cook County Recorder of Deed as document number 1721313046 on August 1, 2017 is declared void and held for naught.
4. That the August 4, 2014 tax sale to Petitioner EQUITY ONE INVESTMENT FUND, LLC for real estate taxes for the year 2012 and prior years on the property identified by permanent index number 18-13-422-035-0000 as evidenced by Certificate of Purchase of No.: 12-0002316 is declared a sale in error.
5. The County Treasurer is directed to refund to Petitioner EQUITY ONE INVESTMENT FUND, LLC, or its Assignee the principal amount of the sale plus all costs posted to the tax judgment, sale, redemption and forfeiture record corroborated by attached receipt, certified copy of judgment book or affidavit.
6. The County Treasurer is directed to refund to Petitioner EQUITY ONE INVESTMENT FUND, LLC or its Assignee, subsequent taxes paid but not posted to the tax judgment, sale, redemption and forfeiture record by the Petitioner for the years: 2016 2<sup>nd</sup> Installment that is corroborated by attached receipt or affidavit. The County Treasurer is also directed to refund to Petitioner EQUITY ONE INVESTMENT FUND, LLC or its Assignee, all court reporter

fees for the hearing on the application for tax deed and transcript, thereof, costs of certification of tax deed order, cost of issuance of tax deed and cost of recording of tax deed that is corroborated by attached receipt or affidavit.

7. The refund shall be awarded:

  X   with interest thereon in accord with 35 ILCS 200/21-310 and 200/21-315;

EQUITY ONE INVESTMENT FUND, LLC shall tender a copy of the certificate, posting receipts, receipts for cost not posted and a stamped copy of the order to the County Treasurer and Ex-Officio County Collector of Cook County within ten (10) days of the date hereof. If the above documentation supporting the issuance of the check is not received within 10 days, interest accrual will cease on the eleventh day and will not begin to accrue again until the date when those documents are received by the County Treasurer.

8. The County Treasurer shall tender the refund check to EQUITY ONE INVESTMENT FUND, LLC when EQUITY ONE INVESTMENT FUND, LLC presents this Order to the Cook County Clerk.

9. The County Treasurer and Ex-Officio Collector of Cook County and the Cook County Clerk mark their official books and records to reflect the vacation of the aforementioned tax sale and the entry of this order.

10. The above-referenced case is hereby dismissed.
