FINAL JUDGMENT ORDER

This cause coming to be heard on the Complaint For Condemnation filed by The Department of Transportation of the State of Illinois ("Department") to acquire the full fee simple title to the real property designated as Parcel 0JU0003, and to ascertain the just compensation to be paid for this acquisition, and on the Stipulation and Settlement Agreement filed herein, and the Court having been duly advised in the premises;

THE COURT HEREBY FINDS:

- 1. The Department is represented by Lisa Madigan, Attorney General of the State of Illinois, by James R. Carr, Special Assistant Attorney General, Carr Law Firm LLC, 123 N. Wacker Drive, Suite 1600, Chicago, Illinois.
- 2. The defendant, Bartlett 59 LLC, an Illinois Limited Liability Company ("Bartlett 59 LLC"), is represented by Paul W. Carroll, Gould & Ratner LLP, 222 N. LaSalle Street, Chicago, Illinois.

- 3. Parcel 0JU0003 is part of a larger parcel measuring approximately 110.894 acres which is located at the northwest corner of the intersection of Illinois Route 59 and West Bartlett Road in the Village of Bartlett, Cook County, Illinois (the "Subject Property").
- 4. The Court has jurisdiction over the parties and over the Subject Property in this proceeding.
- Agreement, which has been filed with the Court. The Department and Bartlett 59 LLC waive their rights to a trial by jury. Accorporate the terms of the Stipulation and Settlement Agreement into this Final Judgment Order by receivace, and consent to the entry of this Final Judgment Order.
- 6. On April 10, 2015, the Department filed a Complaint For Condemnation to acquire Parcel 0JU0003. On April 10, 2015, fee simple title to the Subject Property was held by Bartlett 59 LLC.
- 7. Pursuant to the Department's Motion for Immediate Vesting of Title, this Court entered an order on May 21, 2015 determining the preliminary just compensation to be TWENTY-TWO THOUSAND SEVEN HUNDRED DOLLARS (\$22,700.00).
- 8. On June 9, 2015, the Department deposited the preliminary just compensation amount of \$22,700.00 with the Cook County Treasurer, and on June 11, 2017 the Court entered an Order Vesting Title.
- 9. All defendants have been served with process, and the Court has jurisdiction over the parties to this proceeding and over the Subject Property in this proceeding.
- 10. On March 1, 2017, the Court entered judgment by default against the defendants, Unknown Owners and Non-Record Claimants.

- Parcel 0JU0003, as agreed upon by the parties as stated in the Stipulation and Settlement

 Agreement, including compensation for the property rights being taken and for any or all damage to the remainder, including costs to cure, whether claimed or unclaimed, arising out of the taking is TWENTY-TWO THOUSAND SEVEN HUNDRED DOLLARS (\$22,700.00).
- The Department shall be entitled to a Satisfaction and Release of Judgment upon entry of this Final Judgment Order.
- 13. The Department and Bartlett 59 LLC have waived any claims for payment of costs and attorneys' fees.
 - 14. Bartlett 59 LLC has waived any claim for interest, statutory or otherwise.
- 15. The Department and Battle 39 LLC have agreed not to appeal this Final Judgment Order.

IT IS HEREBY ORDERED, ADJUDGED AND DECREED THAT:

- A. The full and final just compensation, including compensation for the property rights being taken and for any or all damage to the remainder, including costs to cure, whether claimed or unclaimed, arising out of the taking and for statutory interest thereon is TWENTY-TWO THOUSAND SEVEN HUNDRED DOLLARS (\$22,700.00).
- B. This Final Judgment Order is hereby declared satisfied, and the Judgment entered herein against the Department is hereby released.
- C. The Order Vesting Title, which was entered herein on June 11, 2017, is confirmed in respect to the property interests acquired by the Department in Parcel 0JU0003.
- D. This is a final judgment order, and there is no just reason for delaying enforcement or appeal of this order.
