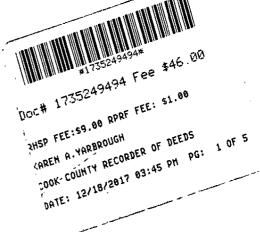

MODIFICATION OF MORTGAGE

THIS MODIFICATION OF MORTGAGE dated November 14 2017, is made and executed between MATHEW M. JOSEPH and MERCY M. To delete from the paragraph titled "Note" the following: "The maturity date of the Note is November 14, 2017".

Except as expressly modified above, the terms of the original Mortgage shall remain unchanged and in full force and effect and are legally valid, binding, and enforceable in accordance with their respective terms.
