WHEREAS, the City filed its Petition for Appointment of a Limited Receiver in the Building Code Case pursuant to 65 ILCS 5/11-31-1,5/11-31-2 and 5/17-13-15.

WHEREAS, On or about May 23, 2016, the Court entered an Order Appointing A Limited Receiver and Authorizing Action by the Receiver ("Appointment Order"), inter caa, appointing CR Realty Advisors LLC ("Receiver") a limited receiver with respect to all or a portion of the Property and authorizing Receiver to issue a receiver's certificate for the cost and expenses of the receivership.
