AN ORDINANCE APPROVING MODIFICATIONS TO THE PREVIOUSLY APPROVED SITE PLAN FOR THE PLANNED DEVELOPMENT AT 8063-8115 FLORAL AVENUE, 8126-8166 FLORAL AVENUE AND 5135 CLEVELAND STREET, SKOKIE, ILLINOIS IN R3 COMBINED HOUSING AND CX CORE MIXED-USE DISTRICTS

WHEREAS, or. September 15, 2014, the Mayor and Board of Trustees of the Village of Skokie adopted Village Ordinance Number 14-9-Z-4094 to grant site plan approval for a 24 unit single family planned development, in two phases. This ordinance was amended by Village Ordinance 15-12-Z-4189, through the modified review process. The affected property is legally uses ribed as follows:

WHEREAS, Floral Avenue, LLC, the developer of the property legally described above (hereinafter "Developer") requested that they be permitted to modify the previously approved and subsequently modified site plan to reflect the following:

- to allow for the extension of the deadline for all building permits to be applied for and issued to September 30, 2017;
- that all houses be sold and constructed by June 30, 2018; and

WHEREAS, the Phase 1 portion has been completed and Phase 2 is underway with only three more lots to be transferred from the Village to the Developer; and

WHEREAS, pursuant to Section 118-8(c) of the Skokie Village Code, the Corporation Counsel, Plan Commission Chairman and Community Development Director reviewed the request and found that the requested modifications are in substantial compliance with the site plan approval granted on December 7, 2015; and

WHEREAS, it was recommended to the Mayor and Board of Trustees that the requested modifications be granted; and

WITEREAS, at a public meeting duly held June 19, 2017, the Mayor and Board of Trustees concurred in the aforesaid recommendations and findings of fact of the Corporation Counsel, Plan Commission Chairman and Community Development Director;

NOW, THEREFORE, BE IT ORDAINED by the Mayor and Board of Trustees of the Village of Skokie, Cook County, Illinois:

Section 1: That the existing site plan approval, Village Ordinance Number 14-9-Z-4094, Conditions 14 and 21, for the planned development at the Subject Property, be and the same is hereby modified as follows below. The new material is **highlighted** in **bold** and the material to be deleted is eighlighted and stricken through.

- Building permits must be applied for and issued on all lots in the planned development by December 31, 2016 September 30, 2017. This ordinance may be extended beyond that point with a modified review approval by the Village Board prior to said date.
- 21. The Developer shall install new public sidewalks 5 feet wide, adjacent to the development site prior to occupancy of any unit on a lot adjacent to a public street or escrow 110% of the cost of the installation. The Developer shall install all sidewalks prior to the issuance of a Certificate of Occupancy of the second to the last house in each phase or before Developer 31, 2016

 June 30, 2018, whichever is first.

<u>Section 2</u>: That a notice of the approval of this Ordinance incorporating the modifications contained herein shall be executed by the Developer of the property in writing and duly recorded with the Cook County Recorder of Deeds Office at the Developer's expense.

<u>Section 3</u>: That this Ordinance shall be in full force and effect from and after its passage, approval and recordation as provided by law.
