MODIFICATION AGREEMENT (HOLDINGS) (Mortgage)

This Modification Agreement (Mortgage) ("Modification) greement") is made as of October 26, 2017, by VINAYAKA HOLDINGS CORPORATION ("Mortgagor") and CIBC BANK USA, formerly known as THE PRIVATEBANK AND TRUST COMPANY ("Mortgagee").

Factual Background

- A. Mortgagor executed a certain Mortgage, Assignment of Rents, Security Agreement and Fixture Filing, for the benefit of Mortgagee, dated February 29, 2016, and recorded on March 2, 2016, as Instrument Number 1606229903, in the Official Records of Cook County, State of Illinois Granting a mortgage lien on property located at 1000 East Woodfield Road, Schaumburg, Illinois 60173 (the "Mortgage"). The Mortgage encumbers the real property described in Exhibit "A" attached here of and incorporated herein.
 - B. Mortgagor and Mortgagee desire to amend the Mortgage as set forth below.

Agreement

Therefore, Mortgagor and Mortgagee agree as follows:

1. All capitalized terms not otherwise defined herein shall have the meanings given to them in the Mortgage.

2. The Loans and Notes secured by the Mortgage have changed or have been modified.

Accordingly, Sections 2.1 of the Mortgage is hereby modified, amended and restated to read as follows:

"2. THE SECURED OBLIGATIONS.

- 2.1 <u>Purpose of Securing</u>. Mortgagor makes the grant, conveyance, transfer and assignment set forth in Section 1, makes the irrevocable and absolute assignment set forth in Section 3, and grants the security interest set forth in Section 4, all for the purpose of securing the following obligations (the "Secured Obligations") in any order of priority that Mortgagee may choose:
- (a) Payment of all obligations of Mortgagor, Vinayaka Hospitality Lisle, LLC, Vinayaka Holdings Corporation, Vinayaka Hospitality, LLC and Vinakom Inc. (collectively "Obligo") o Mortgagee arising under the following instrument(s) or agreement(s) (collectively, the "Debt Inst un ent").
 - (i) A Revolving Note, dated as of July 10, 2016, payable by Vinakom, Inc. as maker in the stated principal amount of Two Million Dollars (\$2,000,000) to the order of Mortgagge ("Revolving Loan") as amended, renewed, or restated.
 - (ii) A Term Note No. 1, dated as of October 26, 2017, payable by Vinayaka Holdings Corporation as maker in the stated principal amount of One Million Three Hundred Four Thousar. 3 Eight Hundred Thirty Dollars and 28/100 (\$1,304,830.28) to the order of Mortgagee ("Term Loan No. 1") as amended, renewed, or restated.
 - (iii) A Term Note No. 2, dated as of October 26, 2017 payable by Vinayaka Holdings Corporation as maker in the stated principal amount of One Million Two Hundred Thirteen Thousand Seven Hundred Fifty Two Dollars and 59/100 (\$1,213,752.59) to the order of Mortgagee ("Ter n Loan No. 2") as amended, renewed, or restated.
 - (iv) An Amended and Restated Term Note No. 3, dated as of February 29, 2016, payable by Vinayaka Holdings Corporation as maker in the stated principal amount of One Million Eight Hundred Eighty Three Thousand Six Hundred Sixty Two Dollars and 26/100 (\$1,883,662.26) to the order of Mortgagee ("Term Loan No. 3") as amended, renewed, or restated.
 - (v) A Term Note No. 4 dated as of October 26, 2017, payable by Vinayaka Hospitality, LLC as maker in the stated principal amount of Two Million Seven Hundred Seventeen Thousand Six Hundred Seventy Three Dollars and 54/100 (\$2,717,673.54) to the order of Mortgagee ("Term Loan No. 4") as amended, renewed, or restated.
 - (vi) A Term Note No. 5, dated as of March 20, 2014, payable by Vinayaka Hospitality Lisle, LLC as maker in the stated principal amount of Eleven Million Five Hundred Thousand Dollars and 00/100 (\$11,500,000) to the order of Mortgagee, ("Term Loan No. 5"), as amended, renewed, or restated.

(vii) A Term Note No. 6, dated as of February 29, 2016, payable by Vinayaka Holdings Corporation as maker in the stated principal amount of Five Million Nine Hundred Fifteen Thousand Dollars and 00/100 (\$5,915,000) to the order of Mortgagee, ("Term Loan No. 6"), as amended, renewed, or restated.

(viii) A Term Note No. 7, dated May 25, 2017 payable by Vinayaka Hospitality Lisle LLC as maker in the stated principal amount of Two Million Five Hundred Thousand Dollars and 00/100 (\$2,500,000) to the order of Mortgagee ("Term Loan No. 7") as amended, renewed or restated.

(ix) A Term Note No. 8, dated October 26, 2017 payable by Vinayaka Hospitality LLC as maker in the stated principal amount of One Million Dollars and 00/100 (\$1,000,000) to the order of Mortgagee ("Term Loan No. 8"), as amended, renewed or rectared.

(x) A certain Loan and Security Agreement, dated as of December 19, 2011, as amended by that First Amendment dated as of January 27, 2012, a Second Amendment dated as of November 16, 2012, a Third Amendment, dated as of May 22, 2013, that Fourth Amendment, dated March 20, 2014, that Fifth Amendment, dated as of March 19, 2015, that Sixth Amendment, dated as of July 12, 2015; Seventh Amendment, dated as of February 29, 2016; Eighth Amendment dated July 10, 2016; Ninth Amendment, dated Aug ist 9, 2016; and that Tenth Amendment, dated May 25, 2017, and an Eleventh Amendment dated as of October 26, 2017 hereof between Obligor and Mortgagee which provides for extensions of credit in an aggregate principal amount not exceeding Thirty Million Thirty Four Thousand and Nine Hundred Eighteen Dollars and 67/100 (\$30,034,918.67) (the "Loan Agreement") as reaffirmed, amended, renewed, or restated.

(xi) A certain Continuing Uncorditional Guaranty dated December 19, 2011, as reaffirmed by that Second Amendment and Inird Amendment to the Loan Agreement, in the principal amount of Two Million Dollars (\$2,000,000) given by Mortgagor and Ketukumar Amin to Mortgagee in support of the obligations of Vinakom, Inc. to Mortgagee as reaffirmed, amended, renewed, or restated.

(xii) An Amended and Restated Continuing Unconditional Guaranty, dated as of November 16, 2012, given by Vinakom Inc. and Ketukumar frain to Mortgagee in support of the obligations of Vinayaka Holdings Corporation to Mortgagee, as reaffirmed, amended, renewed, or restated.

(xiii) Continuing Unconditional Guaranty dated as of November 16, 2012 given by Vinakom, Inc., Vinayaka Holdings Corporation, Ketukumar Amin and Komalbula Patel to Mortgagee in support of the obligations of Vinayaka Hospitality, LLC to Mortgagee as reaffirmed, amended, renewed, or restated.

(xiv) Continuing Unconditional Guaranty dated as of March 20, 2014, given by Vinakom, Inc., Ketukumar Amin and Komalbula Patel to Mortgagee in support of the obligations of Vinayaka Hospitality Lisle, LLC to Mortgagee, as reaffirmed, amended, renewed, or restated.

- (b) This Mortgage also secures payment of all obligations of Obligor under the Debt Instrument which arise after the Debt Instrument is extended, renewed, modified or amended pursuant to any written agreement between Obligor and Mortgagee, and all obligations of Obligor under any successor agreement or instrument which restates and supersedes the Debt Instrument in its entirety.
- (c) Payment and performance of all obligations of Mortgagor under this Mortgage;
- (d) Payment and performance of all obligations of any Obligor under any Swap Contract "Swap Contract" means any document, instrument or agreement with Mortgagee, now existing or entered into in the future, relating to an interest rate swap transaction, forward rate transaction, interest rate cap, floor or collar transaction, any similar transaction, any option to enter into any of the foregoing, and any combination of the foregoing, which agreement may be oral or in writing, including, without limitation, any mast at ingreement relating to or governing any or all of the foregoing and any related schedule or confirmation, each as amended from time to time; and
- (e) Payment and performance of all future advances and other obligations that Mortgagor (or any successor in interest to Mortgagor) or Obligor (if different from Mortgagor) may agree to pay and/or perform (whether as principal, surety or guarantor) to or for the benefit of Mortgagee."

3. Except as provided in this Modification Agreement, the terms of the Mortgage remain in full force and effect.
