- 3. The Village will not be required to maintain or replace any of such system as nie y be damaged by such work or by any other maintenance or construction operation; such as, but not limited to, snow plowing, installation or repair of the sidewalk.
- 4. All sprinkler heads will be so constructed that they will not project above ground leve! where located.
- 5. All sprinkler heads will be so located, shielded, adjusted or directed that they will not sprinkle the public pavement or public sidewalk when in operation.
