FIRST MODIFICATION AGREEMENT

THIS FIRST MODIFICATION AGREEMENT (the "Agreement") is entered into effective as of January 1, 2018, by and between MCR MT PROSPECT LLC, a Delaware limited liability company ("Borrower"), and SIMMONS BANK, a national banking corporation ("Bank").
