

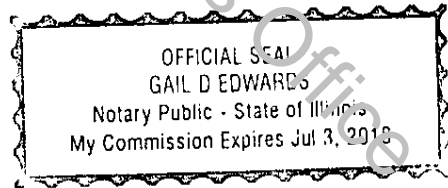

Exhibit A - Legal Description

Parcel 1:

Unit No. 4N, in 15 South Racine Condominiums, as delineated on a Plat of Survey of the following described Tract of Land: Lots 26 and 27 and the North Half of Lot 28 in Hayes Subdivision of Block 2 of Canal Trustee's Subdivision of the West Half and the West Half of the Northeast Quarter of Section 17, Township 39 North, Range 14, East of the Third Principal Meridian, which Plat of Survey's attached as Exhibit "D" to the Declaration of Condominium Ownership recorded May 13, 2009, as Document No. 0913316026, and as Amended from Time to Time, together with its undivided percentage interest in the common elements, all in Cook County, Illinois.
