- 1. This lien has been filed pursuant to 65 ILCS 5/11-20-15.1; subsection (d) of Section 11-20-7 - Cutting and removal of neglected weeds, grass, trees, and bushes; subsection (e) of Section 11-20-13 - removal of garbage, debris, and graffiti; and Section 11-31-1.01 - securing or enclosing abandoned residential property.
- 2. On September 30, 2014, a notice to abate weeds, dangerous trees, and debris from the property described above, which was found to be in violation of Section 7-172 of the Justice Municipal Code, Weeds, Debris Declared Nuisance, was sent to the property owner at their last known address.
- 3. On November 12, 2014, services to remedy the nuisance by the Village were ordered and the dangerous trees were removed. An invoice in the amount of \$5,050.00 for services rendered by the "Claimant" to the property owner on November 12, 2014 was submitted to the property owner Ben Krzesay for one inspector to determine the status and conditions of the property, labor to remove the violation, and pictures taken.

- 4. On March 16 2015, the Village of Justice Public Works Department rodded the sanitary clean out for the property at a cost of \$175.00. Notice was sent to the property owner on March 31, 2016.
- 5. On March 22, 2016, raw garbage and household items were strewn about the property in and around the dumpster area. Notification was made on March 26, 2016, to the property owner of violation of Justice municipal code Section 7-232 (waste accumulation) and subsection (e) of Section 11-20-13 removal of garbage, debris, and graffiti declared a nuisance. As an emergency situation, the Village cleaned up the area and submitted their invoice in the amount of \$409.03.
- 6. On August 10, 2017, the owner of records was sent a notice of failure to license the property under Justice Municipal code 8-507 through 8-514. Outstanding license fees due totaled \$940.00.
- 7. On September 8, 2017, under the authority of the International Property Maintenance Code Section 109.4, emergency repair, and 65 ILCS 5/11-20-7(d), cutting and removal of neglected weeds, grass, trees, and bushes, and subsection 11-20-13, removal of garbage, debris, and graffiti, the building commissioner authorized the Village of Justice Public Works Department to remove all garbage, debris, grass and weeds from the property An invoice was submitted to the owner in the amount of \$689.92.
- 8. On November 1, 2017, an inspection of the property found that the property was not fit for human occupancy and was condemned by the Building Commissioner. The building was posted "Not approved for occupancy" "Condemned" and Failure To License". December 5, 2017, under Section 11-31-1.01 securing or enclosing abandoned residential property, the Village ordered the property to be secured. An invoice in the amount of \$4,278.00 was submitted. A total invoice for services rendered by the Village was sent to the owner and the mortgage holder in the amount of \$15,035.25 on January 10, 2018.
- 9. That by reasons of the above, the total lien amount claimed as of January 10, 2018 is \$15,035.25 for Nuisance Abatement costs, lien recording fees and document prep. Claimant claims a lien on the Property (including all land and improvements thereon) in the amount of \$15,035.25 plus any fines and or costs applicable after the date hereof.
