This Second Amendment is made and entered into on this 15<sup>th</sup> day of January, 2018 and is an amendment to the Declaration of Covenants, Conditions, Restrictions and Easements for Park St. Claire (the "Declaration") recorded on August 23, 1990 as Document No. 90412469 with the Recorder of Deeds for Cook County, Illinois, and covers the property (hereafter the "Property") legally described in Exhibit "A," which is attached hereto and made a part hereof.

This Amendment is adopted pursuant to the provisions of Section 1-60 of the Illinois Common Interest Community Association Act (765 ILCS 180/1-60 (a)) to permit the Association to come into compliance with Section 20 of the Homeowners' Energy Policy Statement Act (765 ILCS 165/1 et. seq.). The text of this Amendment, which is set forth below, shall become effective upon recordation in the Office of the Recorder of Deeds, Cook County, Illinois.

## RECITALS

WHEREAS, the Board of Directors of Park St. Claire Homeowners Association (the "Association") desires to amend the Declaration to come into compliance with Section 20 of the Homeowners' Energy Policy Statement Act (765 ILCS 165/1 et. seq.); and

WHEREAS, this Amendment is adopted pursuant to the provisions of Section 1-60(a) of the Illinois Common Interest Community Association Act (765 ILCS 180/1-60 (a)). Said section provides that if a provision of the community instruments does not conform to the Illinois

Common Interest Community Association Act or to another applicable law because of an error, omission, or inconsistency in the community instruments of the association, the association may correct the error, omission, or inconsistency to conform the community instruments to this Act or to another applicable law by an amendment adopted by vote of two-thirds of the

board of directors, without a membership vote. Section 1-60 further provides that a provision in the community instruments requiring members of record to vote to approve an amendment to the community instruments, or for the members of record to be given notice of an amendment to the community instruments, does not apply to an amendment that corrects an omission, error, or inconsistency to conform the community instruments to this Act or to another applicable law.

NOW, THEREFORE, the Association hereby declares that the Declaration be and is hereby amended as follows (additions to text are shown as underlined and deletions to text are shown as a ~~strikeout~~):

1. Article Six, "Use, Occupancy and Maintenance Restrictions" is amended to add and include following the text as a new Section 14 "Energy Policy Statement" as follows:

## **Section 14. Energy Policy Statement**

PURPOSE OF STATEMENT: In compliance with the Section 5 of the Homeowner's Energy Policy Statement Act (765 ILCS 165/1 et. seq.) the Board of Directors for Park St. Claire Homeowners Association has adopted this Energy Policy Statement for purposes of protecting the public health, safety, and welfare of the members of the Association, while encouraging the development and use of solar energy systems in order to conserve and protect the value of land, buildings, and resources.

- (a) The terms used herein shall have the meaning and definitions prescribed to them in Section 10 of the Homeowner's Energy Policy Statement act.
- (b) Application for the installation of a solar energy system must be made to the Design Review Committee as described in the Rules and Regulations regarding maintenance and modifications of individual homes and properties with a copy provided to the Board of Directors for the Association. The Design Review Committee submission needs to be accompanied by a plan that is "to scale" from the contractor who will be installing the system with material and/or manufacture's description of system, photos/pictures of system and color of system. Supporting materials to be submitted with the Design Review Committee submission must, at minimum, contain specific descriptions, drawings, photographs, and/or specifications, related to items (c) though (n) below in order to be considered.
- (c) All solar energy systems must be designed and installed by a professional licensed solar contractor.
- (d) Solar energy systems can either be "flush mounted" or "tilt mounted". However, to integrate the solar energy system into the design of the home, the solar energy system array must be flush mounted, that is, match the existing plane of the roof (parallel to roof line), unless on a flat roof. If installed on a flat roof, the array may be tilted to allow proper exposure to the sun provided that a letter is

provided to the Design Review Committee from the solar professional involved explaining the need for a tilt mounted array.

(e) A solar energy system may be installed on the roof within an orientation to the south or within 45 degrees east or west of due south provided that the determination does not impair the effective operation of the solar energy system. Any deviation from the orientation requirement in this section must be done upon approval by the Design Review Committee with a written explanation from the solar professional involved which explains any request for deviation from the orientation standards described in this section. In the event that future technology or technical designs allow for alternative orientations to be utilized, the Association and Design Review Committee will give preference to designs and orientations which are the most aesthetically pleasing to the community.

(f) Components of the solar energy systems must integrate into the design of the homes. The color of the solar energy system components should generally conform to the color of the roof shingles to the extent practical (for instance, black frames on dark colored shingles, silver frames on light colored shingles). Solar "shingles" which mimic the look of a composite shingle are acceptable but should match the color of the current roof shingles as much as practical.

(g) Installation of a solar energy system shall not adversely impact adjacent property owners. All systems shall be designed and located so as to avoid glare or reflection onto adjacent properties. The Association shall have no obligation to intervene in civil disputes between Owners concerning solar energy systems installed in accordance with this Declaration and/or Federal, State, and local laws.

(h) All solar energy systems shall have a readily identifiable and accessible external disconnect switch to disconnect power at the solar panel.

(i) The Owner having a solar energy system shall be solely responsible for its maintenance, upkeep and repair and shall, at all times, keep said system and each of its components in properly working order including but not limited to repainting or replacement of the exterior solar collectors, solar storage mechanism or other components as needed.

(j) All solar energy systems shall meet applicable standards and requirements imposed by federal, state and local authorities specifically including Village of Schaumburg ordinances, the National Electrical Code and Illinois Plumbing Code. The owner installing a solar energy system is responsible for obtaining all necessary state and local permits and inspections required in connection with installation and operation. Copies of such permits shall be furnished to the Association upon request.

(k) Electric solar energy components must have an Underwriters Laboratory (UL) listing or approved equivalent and solar hot water systems must have a Solar Rating Certification Corporation (SRCC) rating.

- (l) All plumbing lines should be concealed where possible on the exterior of the home and the method of installation shown and detailed. Lines should be painted colors consistent with the structure and other materials adjacent to the system.
- (m) Any material used in the solar collectors, solar storage mechanism and solar energy system, if flammable, should be self-extinguishing.
- (n) Solar collectors, solar storage mechanism and solar energy system not on the roof (ground mounted) should be maintained at proper set-backs as set forth in local building codes. Solar collectors, solar storage mechanism and solar energy system should be concealed from neighbors' view when reasonably possible.
- (o) Owner shall hold harmless the Association and managing agent for the Association from all liability, damages, claims or causes of action, of any nature whatsoever, related to or caused as a result of the installation or operation of any solar energy system. Approval granted by the Association for installation of a solar energy system is solely for the purpose of maintaining continuity of such systems installed by owners throughout the community. The Association has no obligation or responsibility to ensure that the system has been installed properly or in accordance with safety standards.
- (p) Any owner who elects to install a solar energy system as outlined above shall provide proof of such system being covered by their homeowner's insurance policy as related to liability for property damage or personal injury.
- (q) The installation, placement or construction of wind energy collection systems is prohibited. Rain water collection systems, and composting systems are permissible, provided that the Owner obtains written authorization from the Design Review Committee or Board of Directors to install such system in advance, and the proposed system complies with any established Rules & Regulations for the Association concerning such systems.
- (r) The Board of Directors for the Association shall have the right to adopt Rules and Regulations regarding the use of solar energy systems, rain water collections systems, and composting systems which are not inconsistent with the provisions of this Amendment.

2. The language of this Amendment shall govern any conflicts between this document and the Declaration and its amendments.

3. Except as expressly set forth herein, the Declaration shall remain in full force and effect in accordance with its terms.
