The Mortgage and Note together, as they may previously have been amended are referred to as the "Loan Documents." Capitalized terms used in this Agreement and not defined here have the meaning given to them in the Loan Documents. If there is more than one borrower or mortgagor executing this document, each is referred to as "I." Words signifying the singular (such as "I") shall include the plural (such as "we") and vice versa where appropriate.

This Agreement will not take effect unless the preconditions set forth in Section 2 below have been satisfied.

- 1. My Representations. I certify, represent to Lender, and agree as follows:
 - The Property has no more than rour units.
 - B. The Property currently has no ma er ally adverse physical condition(s).
 - C. I am in default under the Loan Documents. My default under the Loan Documents resulted from my verifiable (1) loss of income or (2) increase in living expenses.
 - D. I currently have sufficient income to support the financial obligations under the Loan Documents, as modified by this Agreement.
 - E. I have provided documentation for **all** income that I receive 'although I am not required to disclose child support or alimony, unless I chose to rely on such income when requesting a loan modification).
 - F. Under penalty of perjury, all documents and information I have previded to Lender in connection with this Agreement are true and correct.
 - G. If I received a discharge in a Chapter 7 Bankruptcy proceeding subsequent to the execution of the Loan Documents, Lender agrees that I will not have personal liability on the debt pursuant to this Agreement.
- 2. Acknowledgements and Preconditions to Modification. I understand and acknowledge that:

- A. Prior to the Modification Effective Date as set forth in Section 3 below, if Lender determines that any of my representations in Section 1 above are no longer true and correct, the Loan Documents will not be modified and this Agreement will terminate. In that event, Lender will have all of the rights and remedies provided by the Loan Documents.
- B. The Loan Documents will not be modified unless and until (1) Lender approves this Agreement and (2) the Modification Effective Date (as defined in Section 3 below) has occurred. In addition, Lender will not be obligated to modify the Loan Documents if I fail to meet any of the requirements under this Agreement.
- The Modification, If all of my representations in Section 1 above continue to be true in all material respects and all preconditions to the modification set forth in Section 2 above have been met, the Loan Documents will automatically become modified on March 1, 2018 (the "Modification Effective Date") and all unpaid late charges that remain unpaid will be waived. If I have failed to make any payments that are a precondition to this modification, this modification will not take effect.
 - A. The Maturity Date remains May 1, 2039.
 - B. The modified principal balance of my Note may include amounts and arrearages (including unpaid and deferred interest, foreclosure legal fees and costs, escrow items, and ciner costs, but excluding unpaid late charges and administrative fees, collectively "Unpaid Amounts") less any amounts paid to Lender but not previously crecited to my Loan. The new principal balance of my Note will be \$190,231.52 (the "New Principal Balance"). By agreeing to add Unpaid Amounts to the outstanding principal balance, the added Unpaid Amounts accrue interest based on the interest rate in effect under this Agreement. This means that interest will now accrue on the unpaid interest that is added to the outstanding principal palance, which would not happen without this Agreement.

In servicing your loan, the Bank may have incurred third party fees or charges that were not invoiced before we calculated the Unpaid Amounts. If so, these fees and charges will appear on your monthly statement under "Fees and Charges." These fees and charges will not accrue interest or late fees. You may pay these fees and charges at any time. If not previously oaid, you must pay these fees and charges at the earliest of (1) the date you sell or transfer an interest in the Property, (2) the date you pay the entire New Principal Balance, or (3) the Maturity Date.

C. Interest at the fixed rate of 4.500% will begin to accrue on the New Principal Balance as of February 1, 2018 and my first new monthly payment on the New Principal Balance will be due on March 1, 2018. My fully amortizing payment schedule for the modified Loan is as follows:

- E. The interest rate set for h in this Agreement shall apply even in the event of default and if the Loan [/ocuments permitted a default rate of interest.
- Additional Agreements. Lender and Lagree to the following:
 - A. I authorize Lender to attach an Exhibit A to this loan modification, which will include a Legal Description, recording information of the original security instrument, and any other relevant information required by a County Clerk's Office to allow for recording if and when recording becomes necessary for Lender.
 - B. All persons, or their authorized representative(s), who signed the Loan Documents have signed this Agreement, unless (1) a porrower or co-borrower is deceased; (2) the borrower and co-borrower are divorced and the property has been transferred to one spouse in the divorce decree, meaning that the spouse who no longer has an interest in the property need not sign this Agreement (although the non-signing spouse may continue to be hold liable for the obligation under the Loan Documents); or (3) Lender has wrived this requirement in writing. This Agreement may be executed in superate counterparts, each of which shall be deemed an original.
 - C. This Agreement supersedes the terms of any modification, forbearance, trial modification payment plan, or loan workout plan that I previously entered into with Lender.

- E. The Loan Documents are composed of duly valid, binding agreements, enforceable in accordance with their terms and are hereby reaffirmed.
- All terms and provisions of the Loan Documents, except as expressly modified by this Agreement, remain in full force and effect. Nothing in this Agreement shall be understood or construed to be a satisfaction or release in whole or in part of the obligations contained in the Loan Documents.
