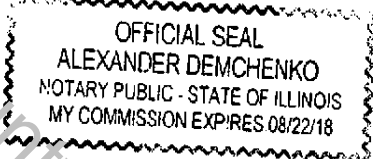

## EXHIBIT "A" PERMITTED EXCEPTIONS

6. Any liens, claims, encumbrances or exceptions to title arising from or otherwise due to actions of the Grantee; and
