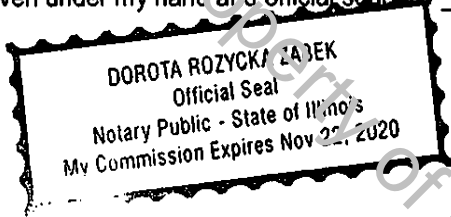

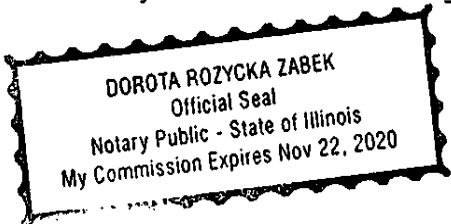

PARCEL 1:

PARCEL 2:
