#### RIDER A TO UCC-1 FINANCING STATEMENT

All of Debtor's rights, title, and interests in, to, and under the following property, rights, interests, and estates, whether now owned or hereafter acquired by Debtor (collectively, the "Property"):

- (a) <u>Land</u>. The real property described in Exhibit A attached hereto and made a part hereof (the "Land");
- (b) Additional Land. All additional lands, estates and development rights hereafter acquired by Debtor for use in connection with the Land and the development of the Land and all additional lands and estates therein which may, from time to time, by supplemental mortgage or otherwise be expressly made subject to the lien of that certain Mortgage, Assignment of Leases and Rents, Security Agreement and Fixture Filing dated as of March 2 \_\_\_\_, 2018 and made by Debtor to Secured Party (the "Security Instrument");
- (c) <u>Improvements</u>. The buildings, structures, fixtures, additions, enlargements, extensions, modifications, repairs, replacements and improvements now or hereafter erected or located on the Land (collectively, the "**Improvements**");
- (d) <u>Easements</u>.
