

ORDER FOR RECEIVER'S FIRST CERTIFICATE

This matter coming on to be heard on Receiver's Petition for the Court's approval of the first accounting and for authorization to issue a receiver's certificates, with due notice being given to all parties and the Court being fully advised in the premises;

THE COURT FINDS:

- 1. That on April 20, 2017, Glowrotters Engineering Corporation was appointed limited receiver for the purpose of performing specific tas's at the subject premises.
- 2. That Receiver performed specific tasks as detailed in the first accounting for fees and expenses from April 20, 2017 through and including July 31, 2017.
- 3. That Receiver's first accounting states that, in the course of fulfilling its duties, Receiver incurred out of pocket costs totaling \$3,369.00, and that \$8,372.75 in fees were billed for a combined total of \$11,741.75.
- 4. The Court has in rem jurisdiction over the subject property and the Defendants, such as could be located for service of process, received due notice of the receivers appointment, its accounting and its petition for approval of the first accounting. \$5,681.60
