The interest rate is changed from a variable rate to a fixed rate of 5.50%. Payments on the Note are changed from interest only payments, to principal and interest payments. Payments on the Note are to be made in accordance with the following payment schedule: in 59 regular payments of \$2,228.34 each and one irregular last payment estimated at \$323,981.96.
