- 3. On or about September 25, 2017, Contractor entered into a written contract with the Claimant, J.F. Carpentry Services Inc., to provide all necessary material and labor for the provision of drywall and rough carpentry on the Real Estate in return for payment.
- 4. The subcontract was entered into by Contractor and the work was performed by claimant with the knowledge and consent of the Owner. Alternatively, the Owners specifically authorized Contractor and/or its agents to enter into contracts for the improvement of the Real Estate.
- 5. On or about December 15, 2017, the Claimant substantially completed all work required to be performed under its subcontract, which entailed delivery and installation of rough carpentry and drywall materials, for which the amount of one hundred seventy-one thousand eight hundred sixty-five dollars and forty-nine cents (\$171,865.4°) remains unpaid.
- 6. As of this date, the e is due one hundred seventy-one thousand eight hundred sixtyfive dollars and forty-nine cents (\$171,865.49) unpaid and owing to the Claimant,
  after allowing all credite, the sum of which principal amounts bears interest at the
  statutory rate under the Micchanics Lien Act. Claimant claims a mechanic's lien on
  said Real Estate and improvements and on the moneys or other consideration due or
  to become due from the Owner under aid contract against Contractor, and others
  claiming an interest in said property.
- 7. To the extent permitted by law, all waivers of lien heretofore given by Claimant, if any, to induce payment not received are hereby revoked. Acceptance of payment by Claimant of part, but not all, of the amount claimer due hereunder shall not operate to invalidate this notice and claim for lien.
