

- 3. The Lien Claimant passed Resolution No. 998 approving a Redevelopment Agreement with Cerro Grande Supermarket, Inc.
- 4. The Redevelopment Agreement approved the purchase of 19064 Burnham Avenue and 19100 Burnham Avenue by Cerro Grande Supermarket pending actions agreed upon in the Redevelopment Agreement.
- 5. The Redevelopment Agreement states the Lien Claimant shall have a lien on the two parcels of land for a total value of \$70,000.
- 6. Said lien shall be forgivable by the Village in the event that Cerro Grande Supermarket retains owners up of the two parcels for thirty-six (36) months following the closing.
