Amended Article IX, Sec. (A) By-Law:

- (a) Transfer:
- A COOK COOK COOK COOK (1) Subject to Paragraph (b) below, a Unit Owner may, varbout restriction, under the Declaration, sell. give, or devise the entire unit:
- (2) A Unit Owner may lease their Unit for a period of two (2) years. A maximum of two (2) Units in the building can be rented at the same time. A Unit Own a nust obtain approval from the Association prior to leasing their unit to a tenant to ensure that only two (2) units are under lease at any given time. A Unit Owner may extend a tenant's lease beyon't two (2) years only after notifying and obtaining written approval for an extension from the Association. There is no restriction on the number of times a Unit Owner may lease their Unit so long as the Unit Owner has obtained written approval for the lease from the Board and is in compliance with the terms above. All leases must be in writing and comply with the mandates of Paragraph (b) below.

Original Article IX, Sec. (A) By-Law:

(a) Unrestricted Transfer: Subject to Paragraph (b) below, a Unit Owner may, without restriction, under the Declaration, sell, give, devise, lease, or otherwise transfer his entire Unit, Notice of such unrestricted transfer shall be given to the Board, in the manner provided for giving of notices, within five (5) days following consummation of such transfer.
