- A Restatement of the Declaration of Condominium Ownership and of Covenants, Easements and Restrictions was recorded with the Cook County Recorder of Deeds on May 24, 2013 as document number 1314447049 which included the Am indirect set forth in two (2) above;
- 4. The Certification by the Secretary of the Forest Glen Association, Inc., Joseph Smith, that the Unit Owners having at least three-quarters (3/4) of the total vote approved the Amendment was in error; and
- 5. The Plaintiff Counter-Defendant, Barbara Vary, and the Defendant, Counter-Plaintiff, Forest Glen Association, Inc. agree with the Court's recommendation that the Complaint and Amended Counter-Complaint be dismissed with prejudice.
