The interest rate is being changed from a fixed rate of 4.69% to a fixed rate of 5.25%. The loan is being amortized for 15 years at this time. New principal and interest payments in the amount of \$10,130.00 will be due on the 3rd of each month beginning on June 3, 2018 and will continue until paid in full or loan maturity. The borrower will pay a 1% prepayment penalty if refinanced with another financial institution. All other terms and conditions shall remain the same.

CONTINUING VALIDITY.
